Abstract: Clarifies that proof of commercial liability insurance and commercial motor vehicle insurance is required for the registration of escort vehicles and requires that each escort service company operate in accordance with federal law.

<u>Present law</u> requires that each application for registration of an escort vehicle be accompanied by proof that each vehicle operated in this state by the applicant is insured in the same amount as is required for escort companies which are domiciled in this state.

<u>Proposed law</u> removes <u>present law</u> and instead requires proof of commercial liability insurance and commercial motor vehicle insurance, each providing for a minimum of \$500,000 in general liability and workers' compensation coverage.

<u>Proposed law</u> requires each company that operates an escort service be subject to the same maximum hours of service requirements that are applicable to motor carriers as provided in federal law.
