MARRIAGE EG NO IMPACT See Note Page 1 of 1
Provides relative to the waiting period before performing a marriage ceremony

Present law prohibits a marriage officiant from performing a marriage ceremony until 72 hours have elapsed since the issuance of the marriage license. Present law authorizes a judge, justice of the peace, or retired justice of the peace to waive the 72-hour delay. Present law authorizes any officiant authorized to perform marriage ceremonies in the parish of Orleans to waive the 72-hour delay for nonresident parties upon application of the parties. Proposed law retains present law but changes the 72-hour delay to a 24-hour delay.
