INDIGENT DEFENSE: Provides relative to the La. Public Defender Fund

1 AN ACT

To amend and reenact R.S. 15:167(E), relative to the Louisiana Public Defender Board; to provide relative to the Louisiana Public Defender Fund; to provide relative to the disbursement of certain monies by the Louisiana Public Defender Board to district defender offices; to reserve a certain portion of the Louisiana Public Defender Fund

for contingencies that may arise in the districts; and to provide for related matters.

Be it enacted by the Legislature of Louisiana:

Section 1. R.S. 15:167(E) is hereby amended and reenacted to read as follows:

§167. Louisiana Public Defender Fund

10 \* \* \*

E. The board shall dedicate and disburse at least sixty-five percent of the entirety of its annual budget and its funds in the Louisiana Public Defender Fund as defined in Subsection A of this Section each fiscal year to the district defender offices and their indigent defender funds as defined in R.S. 15:168(A) in the various judicial districts throughout the state. This amount shall be fully distributed in the first forty-five days of the fiscal year based on an objective plan published by the board no later than April thirtieth of each calendar year. An additional five percent of the entirety of its annual budget and its funds in the Louisiana Public Defender Fund shall be reserved by the board, designated as "Reserve District Assistance Fund", for contingencies that may arise in the districts. The board may reserve these

funds until a need arises, but it shall not be disbursed for purposes other than district assistance as part of the District Assistance Fund. Any funds disbursed to any district defender office shall be paid in addition to the minimum mandatory sixty-five percent of dedicated and disbursed funds required in this Subsection. The provisions of this Subsection shall not apply to statutorily dedicated funds or funds received through the awarding of grants.

**Abstract:** Requires funds to be distributed in the first 45 days of the fiscal year based upon a plan published by the La. Public Defender Board, and requires that an additional 5% of its annual budget and funds in the La. Public Defender Fund shall be reserved for district assistance.

<u>Present law</u> provides for the creation of the La. Public Defender Fund and requires the La. Public Defender Board to dedicate and disburse at least 65% of its annual budget and its funds in the La. Public Defender Fund each fiscal year to the district defender offices and their indigent defender funds in the various judicial districts throughout the state.

<u>Proposed law</u> retains <u>present law</u> and provides that this amount shall be fully distributed in the first 45 days of the fiscal year based on an objective plan published by the board no later than April 30th of each calendar year.

<u>Proposed law</u> further provides that an additional 5% of the entirety of the board's annual budget and its funds in the La. Public Defender Fund shall be reserved by the board, designated as "Reserve District Assistance Fund", for contingencies that may arise in the districts. The board may reserve these funds until a need arises, but it shall not be disbursed for purposes other than district assistance as part of the District Assistance Fund.

## Summary of Amendments Adopted by House

The Committee Amendments Proposed by <u>House Committee on Administration of Criminal Justice</u> to the <u>original</u> bill:

- 1. Remove the requirement that the funds be dedicated and disbursed by Aug. 15<sup>th</sup> each year and instead require the funds to be fully distributed in the first 45 days of the fiscal year based on an objective plan published by the board no later than April 30th of each calendar year.
- 2. Provide that an additional 5% of the entirety of the board's annual budget and its funds in the La. Public Defender Fund shall be reserved by the board for contingencies that may arise in the districts, to be used only for district assistance.
