1	A CONCURRENT RESOLUTION
2	To express the sincere condolences of the Legislature of Louisiana upon the death of Charles
3	Rodney "Rod" Prejean Sr.
4	WHEREAS, it is with deep regret and profound sorrow that the citizens of Louisiana
5	and the members of the Louisiana Legislature have learned of the passing of Charles Rodney
6	Prejean Sr., age eighty-five, on Good Friday, March 30, 2018, after a lengthy battle with
7	Alzheimer's disease; and
8	WHEREAS, Charles Rodney Prejean Sr. was born on June 9, 1932, to Emile Travis
9	Prejean Jr. and Beulah Guerin Prejean, and was a lifelong resident of Brusly, Louisiana; and
10	WHEREAS, he was a United States Marine Corps veteran who served in the Korean
11	War; and
12	WHEREAS, Rod was a respected businessman in the insurance industry for over
13	fifty-five years as a manager, co-owner, and owner of many agencies, with the final
14	twenty-nine years as owner of Rod Prejean & Associates, Inc.; he was an independent agent
15	and held the designation of Certified Life Underwriter; and
16	WHEREAS, he served the town of Brusly as an alderman for twelve years and as
17	mayor for eight years; he also served on the board of the Louisiana Municipal Association
18	for five years and as its president for one year; and

1	WHEREAS, very active in his community, Rod coached the Addis V.F.W. team for
2	the K.C. Basketball league, was a member of the Brusly Lions Club for many years and
3	served as its president, was a member of the American Legion, the Addis V.F.W., was a
4	member and president of the West Side Golf Club, was a founding member of the Brusly
5	Panther Paws, serving as the organization's first president, was the "Voice of the Brusly
6	Panthers", announcing football games for more than twenty-five years; and
7	WHEREAS, he was honored to be one of the first athletes inducted into the Brusly
8	High School Hall of Fame; and
9	WHEREAS, throughout his adult life, Charles Rodney Prejean Sr. served his church,
10	St. John the Baptist Catholic Church in Brusly, as an usher, lector, as a member of the Parish
11	Council, and as a member of the Diocesan Pastoral Council; and
12	WHEREAS, he was preceded in death by parents, Emile Jr. and Beulah Guerin
13	Prejean; sister, Carol Reeves; and brothers, E. T. Prejean III, and Wayne Prejean Sr.; and
14	WHEREAS, a loving husband, father, grandfather, great-grandfather, and brother
15	whose love of family was of utmost importance in his life, Charles Rodney Prejean Sr. is
16	survived by his loving wife of sixty-two years, Beverly Daigle Prejean; daughters, Debra
17	Salvadras and husband Ronnie, and Michelle Stein and husband Darrin; sons, Charles R.
18	""Chuck"" Prejean and wife Alena, Gordon Prejean and wife Jeannie, Michael Prejean and
19	wife Sonya, and Brian Prejean and wife Lynn; eleven grandchildren, Corey Salvadras,
20	Valerie Prejean Bernard, Chad Prejean, Courtney Salvadras DiBenedetto, Natalie Prejean
