Creates Language Equality and Acquisition for Deaf Kids (LEAD-K) Task Force to develop framework for assessing children who are deaf or hard of hearing to determine language skills and ensure kindergarten readiness

<u>Proposed law</u> creates the Language Equality and Acquisition for Deaf Kids (LEAD-K) Task Force for the purposes of developing a resource for parents to monitor and track deaf and hard of hearing children's expressive and receptive language acquisition and developmental stages toward English literacy; and to develop a framework for assessing children who are deaf or hard of hearing to determine their competencies in language and literacy skills for the purpose of ensuring they are able to achieve kindergarten readiness. <u>Proposed law</u> provides relative to membership and meetings. Further provides for the first meeting to be called no later than August 1, 2018, and for a report to be submitted no later than February 1, 2019. <u>Proposed law</u> provides that the state Department of Education and the Louisiana Department of Health shall provide support staff. <u>Proposed law</u> includes a sunset date of March 1, 2019.
