2 On page 1, line 2, after "R.S. 38:3074(A)(4)" insert "and (8) and (B) and to enact R.S.
3 38:3074(A)(9)"

4 AMENDMENT NO. 2

5 On page 1, line 5, after "department;" insert "to add a member appointed by the
6 Mayor-President of the City of Baton Rouge/East Baton Rouge Parish; to provide relative
7 to terms of office;"

8 AMENDMENT NO. 3

9 On page 1, line 11, after "38:3074(A)(4)" insert "and (8) and (B)" and after "reenacted"
10 insert "and R.S. 38:3074(A)(9) is hereby enacted"

11 AMENDMENT NO. 4

12 On page 1, line 13, delete "sixteen members who" and insert "seventeen members, fifteen
13 of whom"

14 AMENDMENT NO. 5

15 On page 1, line 14, after "governor" delete the period "." and insert a semi-colon "; and
16 "three of whom shall serve by virtue of their office; and one of whom shall be appointed by
17 another means."

18 AMENDMENT NO. 6

19 On page 2, between line 3 and 4, insert the following:

20 "(8) One member shall be appointed by the Mayor-President of the
21 City of Baton Rouge/East Baton Rouge Parish.

22 (9) One member shall be appointed by the governor from the
23 nomination nominations by the members of the board. For the purposes of
24 this Paragraph "board" shall mean the members appointed pursuant to
25 Paragraphs (1) through (7) (8) of this Subsection.

27 ~~B. The governor shall designate the term of office for each member~~
28 ~~of the initial board so that:~~

29 ~~(1) From those members appointed by the parish governments two~~
30 ~~shall be appointed for a one-year term; two shall be appointed for a two-year~~

32 ~~(2) From those members appointed to represent industry, one shall be~~
33 ~~appointed for a one-year term; one shall be appointed for a two-year term;~~

35 ~~(3) From those members appointed to represent users furnishing~~
36 ~~water for municipalities, one shall be appointed for a term of one year and~~
37 ~~one for a term of two years.~~

38 ~~(4) All other members shall serve an initial term of three years.~~
