

HOUSE COMMITTEE AMENDMENTS

2018 Regular Session

Amendments proposed by House Committee on Municipal, Parochial and Cultural Affairs to Reengrossed Senate Bill No. 362 by Senator Ward

1 AMENDMENT NO. 1

2 On page 2, delete lines 17 and 19, and at the beginning of line 20 delete "~~(4)~~" and insert the
3 following:

4 **"(2) "District" means the Capital Area Road and Bridge District created**
5 **by this Part.**
6 **(3)"**

7 AMENDMENT NO. 2

8 On page 2, line 24, after "**public**" change the comma "," to a period "." and delete the
9 remainder of the line and delete lines 25 through 29

10 AMENDMENT NO. 3

11 On page 3, line 3, after "**composed of**" change "~~six~~" to "**seven**"

12 AMENDMENT NO. 4

13 On page 3, line 5, after "**designee**" insert a period "." and delete the remainder of the line and
14 delete lines 6 through 14 and insert the following:

15 **"(2) The president of each parish comprising the district or the**
16 **president's designee.**
17 **(3) The governor shall appoint one resident of the district as a member**
18 **who shall serve at the pleasure of the governor.**
19 **B. Notwithstanding any provision of law to the contrary, a member or**
20 **designee may be a state or local elected official or an employee of the state or of**
21 **any parish or municipality."**

22 AMENDMENT NO. 5

23 On page 3, line 28, after "**president.**" delete the remainder of the line and delete line 29 and
24 on page 4, delete lines 1 and 2

25 AMENDMENT NO. 6

26 On page 4, line 6, after "**duties**" insert a period "." and delete line 27

27 AMENDMENT NO. 7

28 On page 4, line 19, between "**on the**" and "**projects,**" insert "**road or bridge**"

29 AMENDMENT NO. 8

30 On page 4, line 29, between "**about the**" and "**projects.**" insert "**road or bridge**"

31 AMENDMENT NO. 9

32 On page 5, at the end of line 10, change "**herein.**" to "**in this Part.**"

1 AMENDMENT NO. 10

2 On page 5, between lines 22 and 23, insert the following

3 "C. The district may create subdistricts as provided in this Subsection.
 4 The district shall publish notice of its intent to create a subdistrict in the official
 5 journal of the district. At least ten days after publication of such notice in the
 6 official journal of the district, the board shall conduct a public hearing on the
 7 question of creating such subdistrict. Thereafter, the board may designate one
 8 or more project areas within the boundaries of the district as a subdistrict of the
 9 district. Each subdistrict shall constitute a political subdivision of the state and
 10 shall be governed by the board. Each subdistrict shall have the same powers as
 11 the district and shall be given a name and designated as "Capital Area Road
 12 and Bridge Subdistrict No. _____".

13 D.(1) With respect to the bridge constructed pursuant to this Part, the
 14 district shall have all authority granted to parishes to establish, impose, collect,
 15 and enforce tolls and issue revenue bonds secured by revenue from the tolls as
 16 provided in the Bridge Revenue Bond Law.

17 (2) The rate of the tolls provided for in this Subsection shall be fixed and
 18 adjusted in connection with any revenue bonds issued to provide a fund
 19 sufficient, with other revenue from the bridge, to pay for the following:

20 (a) The cost of maintaining, repairing, and operating the bridge.

21 (b) The principal of and the interest on such bonds as such becomes due
 22 and payable and creation of a reserve for these purposes.

23 E. The district may levy taxes, impose parcel fees, and incur debt as
 24 otherwise provided by this Part; however, no proposition authorizing taxes,
 25 fees, or bonds shall be submitted to the voters of the district or of any
 26 subdistrict that does not provide funding for a new Mississippi River Bridge,
 27 connectors from Interstate Highway 10 to the bridge on the west side of the
 28 Mississippi River, and the connection to and widening of Louisiana Highway 30.

29 F. The district may use revenue available to it to pay costs associated
 30 with road or bridge projects which costs may include the following:

31 (1) Costs of studies, surveys, development of plans and specifications,
 32 preparation, implementation and administration, personnel and professional
 33 services costs for architectural, engineering, legal, marketing, financial,
 34 planning, police, fire, public works or other services incurred by the district
 35 directly or on behalf of the district. No charges for professional services may be
 36 based on a percentage of tax revenues.

37 (2) Property acquisition and assembly costs, including but not limited
 38 to acquisition of land and other immovable or movable property or rights or
 39 interests therein, incurred by the district directly or on behalf of the district.

40 (3) On- and off-site preparation costs, including but not limited to
 41 clearance of any area by demolition or removal of any existing buildings,
 42 structures, fixtures, utilities, and improvements and clearing and grading and
 43 including installation, repair, construction, reconstruction, or relocation of
 44 public streets, public utilities, and other public improvements incurred by the
 45 district directly or on behalf of the district.

46 (4) Costs of renovation, rehabilitation, relocation, repair, or remodeling
 47 of any existing buildings, improvements, and fixtures.

48 (5) Costs of construction of public improvements, including but not
 49 limited to buildings, structures, works, utilities, or fixtures, incurred by the
 50 district directly or on behalf of the district.

51 (6) Financing costs of the district, including but not limited to all
 52 necessary and incidental expenses related to the issuance of obligations,
 53 payment of any interest on any obligations which accrues during the estimated
 54 period of construction for which such obligations are issued and thereafter, and
 55 any reasonable reserves related to the issuance of such obligations."

2 On page 5, line 25, after "The" change "commission" to "district"

3 AMENDMENT NO. 12

4 On page 6, line 9, between "major" and "project." insert "road or bridge"

5 AMENDMENT NO. 13

6 On page 6, line 18, after "district" change the comma "," to a period "." and delete the
7 remainder of the line and delete line 19 and insert "The tax may be levied only after the
8 question of its levy has been submitted to the qualified electors of the district or
9 subdistrict at an election held for that purpose and conducted in accordance with the
10 Louisiana Election Code and the majority of those voting in each parish comprising the
11 district or subdistrict have voted in favor of the levy of the tax."

12 AMENDMENT NO. 14

13 On page 6, line 22, change "district, subject to taxation," to "district that is subject to
14 taxation"

15 AMENDMENT NO. 15

16 On page 6, line 24, after "Louisiana." delete the remainder of the line and delete lines 25
17 through 29 and insert "The tax may be levied only after the question of its levy has been
18 submitted to the qualified electors of the district or subdistrict at an election held for
19 that purpose and conducted in accordance with the Louisiana Election Code and the
20 majority of those voting in each parish comprising the district or subdistrict have voted
21 in favor of the levy of the tax."

22 AMENDMENT NO. 16

23 On page 7, line 1, after "Commission" insert a comma "," and delete "and the" delete line
24 2 and at the beginning of line 3 delete "for that purpose,"

25 AMENDMENT NO. 17

26 On page 7, delete lines 14 through 16 and insert the following:

27 "(3) Such bonds may be issued only after the question of their
28 issuance has been submitted to the qualified electors of the district or
29 subdistrict at an election held for that purpose and conducted in
30 accordance with the Louisiana Election Code and the majority of those
31 voting in each parish comprising the district or subdistrict have voted in
32 favor of the issuance of the bonds."

33 AMENDMENT NO. 18

34 On page 7, line 21, after "district" delete the comma "," and delete the remainder of the line
35 and delete lines 22 and 23 and on line 24 delete "therein." and insert "only after the
36 question of its imposition and its purpose, rate, and duration have been submitted to
37 the qualified electors of the district or subdistrict at an election held for that purpose
38 and conducted in accordance with the Louisiana Election Code and the majority of
39 those voting in each parish comprising the district or subdistrict have voted in favor
40 of the imposition of the parcel fee."

1 AMENDMENT NO. 19

2 On page 9, delete lines 20 through 24 and insert "**district. The tax may be levied only after**
 3 **the question of its levy has been submitted to the qualified electors of the district or**
 4 **subdistrict at an election held for that purpose and conducted in accordance with the**
 5 **Louisiana Election Code and the majority of those voting in each parish comprising the**
 6 **district or subdistrict have voted in favor of the levy of the tax.**"

7 AMENDMENT NO. 20

8 On page 10, line 7, after "**1950**" insert a period "." and delete the remainder of the line and
 9 delete lines 8 through 13 and insert "**Such bonds may be issued only after the question of**
 10 **their issuance has been submitted to the qualified electors of the district or subdistrict**
 11 **at an election held for that purpose and conducted in accordance with the Louisiana**
 12 **Election Code and the majority of those voting in each parish comprising the district**
 13 **or subdistrict have voted in favor of the issuance of the bonds. The question with"**
