1 (c) The school enrolled students in prekindergarten through grade ten for the 2017-2018 school year. 2 (d) The school received a letter grade of "A" or "B" or any variation thereof, 3 4 pursuant to the school and district accountability system for the 2014-2015, 2015-5 2016, and 2016-2017 school years. 6 7 Section 2. This Act shall become effective on July 1, 2018; if vetoed by the governor 8 and subsequently approved by the legislature, this Act shall become effective on July 1, 9 2018, or on the day following such approval by the legislature, whichever is later.

Abstract: Allows certain Type 1 charter schools to act as their own local education agencies for funding purposes.

<u>Present law</u> relative to charter school funding, provides that local school boards shall remain the local education agencies for types 1, 3, and 4 charter schools except for charter schools authorized to act as their own local education agencies as provided in <u>present law</u> (R.S. 17:10.7.1 - limited to certain school systems). Provides that types 2 and 5 charter schools shall be considered the local education agencies for purposes of funding and statutory definitions pursuant to rules adopted by the State Bd. of Elementary and Secondary Education (BESE).

<u>Proposed law</u> adds an exception for any Type 1 charter school that meets specified criteria to act as its own local education agency pursuant to rules adopted by BESE. Otherwise retains <u>present law</u>.

<u>Present law</u> defines a Type 1 charter school as a new school operated pursuant to a charter between the nonprofit corporation created to operate the school and a local school board.

Effective July 1, 2018.
