A RESOLUTION

2	To commend Charlie "Coach" Bowman for his service with the St. Tammany Parish School
3	Board and to the community.
4	WHEREAS, Charlie Bowman attended Peabody High School in Alexandria,
5	Louisiana, graduating in 1969 and was captain of the boys' basketball and track teams; he
6	attended Grambling State University from 1969 to 1973, graduated with honors, and
7	received a bachelor of art's degree in education; he is twelve hours shy of receiving his
8	masters degree; and
9	WHEREAS, he is a retired art teacher, coach, and athletic director of thirty-nine
10	years of service at Pearl River High School in St. Tammany Parish; and
11	WHEREAS, Charlie Bowman is a member, trustee, and chairman of the Deacon
12	Ministry of Greater North Shore Full Gospel Baptist Church under the leadership of Bishop
13	Robert J. Taylor and the former state director of Deacons for the Full Gospel Fellowship of
14	Louisiana; in 2017 he received the Ministerial Alliance of Greater St. Tammany Outstanding
15	Community and Service Award and he received the Greater North Shore Full Gospel Baptist
16	Church's 1st Pacesetter for the Millennium Man of the Year; and
17	WHEREAS, Charlie "Coach" Bowman is the founder and director of the Greater
18	North Shore's Summer Rest Camp (an educational camp for children in the summer); for

I	fifteen years, he organized and was the director of The Fellowship of Christian Athletes at
2	Pearl River High School; he created and is the Overseer of Greater North Shore's
3	Community Outreach Program, "Fitness and Movement", and Open Court Basketball; and
4	he piloted and contributed to establishing The Fine Art Survey Program in St. Tammany
5	Parish Schools and the state of Louisiana; and
6	WHEREAS, for 1968 to 1978, he received the award for Pearl River High School's
7	"Teacher of the Decade"; in 1978, 1983, 1996, and 2006 he was Pearl River High School's,
8	"Teacher of the Year"; in 1986 and 1989, he was runner up as "Teacher of the Year"; in
9	1996, he was named "St. Tammany Elf Teacher of the Year"; and, in 2006, he was "VFW
10	Teacher of the Year" for St. Tammany Parish and a Region and State finalist; and
11	WHEREAS, from 1970 to 2010, Coach served the longest and was the only African
12	American Athletic Director in St. Tammany Parish; he also had the longest tenure as an
13	African American "Head Coach" in St, Tammany Parish, thirty-five years; during his years
14	at Pearl River High School, he was the head coach of track and field, cross country,
15	basketball, and tennis; and 1982, 1995, 2001, and 2002, he was the "District Coach of the
16	Year" in Track and Cross Country and state runner up in 2002; and
17	WHEREAS, Charlie "Coach" Bowman has been married to Mary Graham Bowman
18	for thirty-one years, he is the father and stepfather to five children: Christy, Chad, Greg,
19	Lonnie, and Michell, and is the proud grandfather and great-grandfather of fourteen; and
20	WHEREAS, Charlie "Coach" Bowman was and is an inspiration to so many children
21	and generations; and
22	WHEREAS, during a full and productive lifetime, he has demonstrated, in countless
23	ways, his dedication to the welfare of others and has earned the respect and affection of all
24	who know him.
25	THEREFORE, BE IT RESOLVED that the Senate of the Legislature of Louisiana
26	does hereby commend Charlie "Coach" Bowman for his service with the St. Tammany
27	Parish School Board and to the community, does hereby record his outstanding contribution
28	of time and talent and for his hard work, dedication, and continuous commitment, and does
29	hereby extend best wishes for success in his future endeavors.
