Establishes a permit fee for milk and dairy farms and plants

Proposed law requires the La. Dept. of Health to charge the following annual permit fees:

- (1) Dairy farms \$90 per permit
- (2) Dairy plants \$300 per permit
- (3) Single service milk and milk product container or closure manufacturing plants \$300 per permit

## **EXPENDITURE EXPLANATION**

There is no anticipated direct material effect on governmental expenditures as a result of this measure.

## **REVENUE EXPLANATION**

This measure is anticipated to increase self-generated revenue at the La. Dept. of Health (LDH) Office of Public Health by \$55,740 in FY 19 and future fiscal years.

The proposed law requires LDH to charge annual permit fees for dairy farms (\$90), dairy plants (\$300), and single service milk and milk product container or closure manufacturing plants (\$300). Based on the average numbers of permits issued annually, these fees are anticipated to generate \$55,740.
