The proposed resolution requests the Legislative Auditor (LLA) to conduct an audit of contracts of the New Orleans Sewerage & Water Board that spans approximately 5 calendar years. It further requests the LLA to analyze the economy, efficiency, and effectiveness of professional, general, and noncompliance/competitive bid contracts with an individual or entity.

**EXPENDITURE EXPLANATION**

This is an urge and request resolution that may not result in a fiscal impact. To the extent that the LLA performs the audit as specified in the resolution, SGF expenditures would increase by approximately \$46,000 (418 hours X \$110 billable rate) and the agency cannot absorb the additional expense with existing resources. LLA indicates that the New Orleans Sewerage & Water Board has approximately 52 active contracts that are being monitored.

There is no anticipated direct material effect on governmental revenues as a result of this measure.
