Amendments proposed by House Committee on Commerce to Reengrossed Senate Bill No. 442 by Senator Morrell

1 AMENDMENT NO. 1

2 On page 1, line 3, delete "through 3152" and insert "and 3151" and delete "to provide
3 relative to"

13 AMENDMENT NO. 6

14 On page 2, delete lines 1 through 20 in their entirety and insert in lieu thereof the following:

15 **"§3150. DNA testing kits; notice to user**

16 **A. Any company selling kits for DNA testing for any purpose shall**
17 **provide the user of such kit with notice in a concise and easy-to-read manner**
18 **informing the user of all of the following to the extent they apply to the DNA**
19 **testing kit being provided by the company:**

20 **(1) Whether the user's DNA may be used for scientific research or**
21 **analysis unrelated to the service that was purchased, and whether express**
22 **consent is required for such research or analysis.**

23 **(2) Information on the nature of the scientific research and analysis**
24 **unrelated to the service that was purchased that may be conducted with the**
25 **user's DNA.**

26 **(3) Whether the user has the option to withhold consent to the use of his**
27 **DNA for scientific research or analysis unrelated to the service that was**
28 **purchased.**

29 **(4)(a) Whether the user's DNA may be shared with a third party for a**
30 **purpose unrelated to the service that was purchased.**

31 **(b) Whether the user's DNA may be sold to a third party for any**
32 **purpose.**

33 **(5) Whether the user has the ability to have his DNA destroyed by the**
34 **company upon his request.**

35 **(6) A statement as to whether the user relinquishes ownership of his**
36 **DNA by submitting his DNA for testing.**

37 **B. The company shall provide to the user the notices required in**
38 **Subsection A of this Section through either of the following methods:**

1 **(1) A website or mobile application, if the user is required to access the**
2 **website or mobile application in order to obtain the DNA testing service that**
3 **was purchased.**

4 **(2) Through a written notice included in the box in which the testing kit**
5 **is provided."**
