# COSMETOLOGY/BOARD: Requests a study regarding the feasibility of merging the Board of Barber Examiners and the Louisiana State Board of Cosmetology

1	A CONCURRENT RESOLUTION
2	To urge and request the Board of Barber Examiners, the Louisiana State Board of
3	Cosmetology, and the Louisiana Legislative Auditor study the feasibility of merging
4	the two boards and submit a report of their findings to the House Committee on
5	Commerce and the Senate Committee on Commerce, Consumer Protection, and
6	International Affairs.
7	WHEREAS, the Board of Barber Examiners was created in 1928; and
8	WHEREAS, the Board of Barber Examiners is composed of five members; and
9	WHEREAS, the governor appoints each member from a list of names provided by
10	the State Association of Journeymen Barbers, Hair Dressers, Cosmetologists, and
11	Proprietors; and
12	WHEREAS, the members of the Board of Barber Examiners receive compensation
13	fixed by the board for each day in attendance upon its sessions and for necessary subsistence,
14	hotel expenses, and travel expenses; and
15	WHEREAS, the Board of Barber Examiners may employ inspectors, instructors, and
16	such other assistants as are necessary to carry out its functions pursuant to present law; and
17	WHEREAS, the Board of Barber Examiners may employ an attorney to represent
18	it in its functions pursuant to present law; and
19	WHEREAS, the duties of the Board of Barber Examiners is to provide for the
20	issuance of certificates of registration to those qualified to be a barber, and to protect the
21	health and welfare of the general public from communicable diseases; and

1	WHEREAS, the Louisiana State Board of Cosmetology was created in 1950; and		
2	WHEREAS, the Louisiana State Board of Cosmetology is composed of eight		
3	members; and		
4	WHEREAS, each member of the Louisiana State Board of Cosmetology is appointed		
5	by the governor; and		
6	WHEREAS, each member of the Louisiana State Board of Cosmetology shall be		
7	reimbursed for necessary travel and other incidental expenses incurred in the discharge of		
8	their duties; and		
9	WHEREAS, each member of the Louisiana State Board of Cosmetology shall receive		
10	compensation for attendance at meetings and hearings; and		
11	WHEREAS, the Louisiana State Board of Cosmetology may pay the expenses of		
12	attendance of three members each year at a national conference; and		
13	WHEREAS, the Louisiana State Board of Cosmetology may hire or contract for		
14	inspectors, clerical help, legal assistance, and other personnel necessary for its proper		
15	operation; and		
16	WHEREAS, the duties of the Louisiana State Board of Cosmetology are to		
17	administer examinations, issue and renew licenses, ensure that individuals receiving licenses		
18	meet the educational requirements established by the state of Louisiana, and regulate,		
19	control, and monitor members of the cosmetology industry to maintain public health and		
20	welfare standards for the consumer public; and		
21	WHEREAS, it is beneficial to improve the efficiency and effectiveness of		
22	government programs; and		
23	WHEREAS, the United States Government Accountability Office found in a 2016		
24	study that efficiency and effectiveness are increased when a government merges agencies		
25	that are duplicative or overlapping; and		
26	WHEREAS, the current operations of the Board of Barber Examiners and the		
27	Louisiana State Board of Cosmetology may be duplicative or overlapping; and		
28	WHEREAS, the Louisiana Legislative Auditor provides independent assessment and		
29	proactive guidance to help ensure a government that is accountable, efficient, and effective;

1	WHE	REAS, the Louisiana Legislative Auditor provides performance auditing to		
2	evaluate the e	conomy, efficiency, and effectiveness of state agency programs, functions, and		
3	activities and provide that information to legislators and public officials; and			
4	WHEREAS, the state of Louisiana may benefit from the merging of the two boards			
5	by minimizing bureaucracy, using government funding more efficiently, and allowing the			
6	public to be s	erved more effectively.		
7	THEF	REFORE, BE IT RESOLVED that the Legislature of Louisiana does hereby		
8	urge and request the Board of Barber Examiners, the Louisiana State Board of Cosmetology,			
9	and the Louisiana Legislative Auditor to study the feasibility of merging the two boards and			
10	submit a written report of findings, conclusions, and recommendations, to the House			
11	Committee of	n Commerce and the Senate Committee on Commerce, Consumer Protection,		
12	and Internation	onal Affairs by not later than sixty days prior to the convening of the 2019		
13	Regular Session of the Legislature.
