- "§2152. Initial appointments; oaths; panel of names; domicile; officer; bond

A. Each member of the board shall serve at the pleasure of the governor. 18 19 Each appointment by the governor shall be submitted to the Senate for confirmation. 20 Each member shall take and file with the secretary of state the constitutional oath of 21 office before entering upon the discharge of his duties. Any member appointed to fill a vacancy occurring prior to the expiration of the term of his predecessor shall 22 23 be appointed for the remainder of the unexpired term from among residents of the same congressional district as that of the member whose office was vacated. 24 However, if there are no qualified applicants from the congressional district of the 25 26 member whose office was vacated, the governor shall appoint a qualified applicant 27 from any congressional district to fill the vacancy. In making the appointments provided for in this Section, the governor shall appoint at least one person who is 28 29 nominated by the National Association for the Advancement of Colored People, and 30 at least one person who is nominated by the Louisiana Business League.
