3 "Subpart B of Part V of Chapter 11 of Title 23 of the Louisiana Revised Statutes of  
4 1950, to be comprised of R.S. 23:1620.1 through 1620.8, relative to employment;"

6 C. The legislature further finds that it is critical that the unemployment  
7 insurance administration be prepared to expedite unemployment claims for  
8 Louisiana workers who are part of a mass layoff through no fault of their own."
