14 **finds that one incident of family violence has resulted in serious bodily injury**  
15 **or the court finds more than one incident of family violence. In cases in which**  
16 **the court finds a history of committing family violence, the court shall**  
17 **determine an award of custody or visitation in accordance with R.S. 9:341 and**  
18 **364.**"
