COMMENDATIONS: Commends posthumously Sergeant John Ray of Gretna, Louisiana

A RESOLUTION

2	To commend posthumously the unselfish heroism of Sergeant John P. Ray, Jr., during his
3	service in the U.S. Army during World War II.
4	WHEREAS, John Ray was born on August 15, 1922, in Gretna, Louisiana and
5	attended Gretna Elementary School and Gretna High School; he played football for the high
6	school team; and
7	WHEREAS, on January 9, 1941, at the age of eighteen, John Ray enlisted to serve
8	in the military, and once the U.S. entered World War II, John Ray was quickly promoted to
9	the rank of corporal and then sergeant; he proudly served in Company F, 505th Parachute
10	Infantry, 82nd Airborne Division; and
11	WHEREAS, he met the woman he would marry, Paula Freeman, in Gretna, and the
12	two were married on March 7, 1943, in Cut Off, Louisiana; and
13	WHEREAS, a week after their wedding, John shipped out back to his parachute
14	infantry unit in Africa; and
15	WHEREAS, Sergeant John Ray served in World War II with great distinction,
16	participating in the invasions of Africa and Italy; and
17	WHEREAS, on June 6, 1944, Sergeant John Ray was killed in action on D-Day in
18	Saint Mère Église, France; Sergeant John Ray performed his military duties in an
19	outstanding fashion and at great personal sacrifice, exhibiting courage and gallantry in the
20	face of utmost danger; and

1 WHEREAS, the account of Sergeant John Ray's unselfish heroism is well 2 documented in the books D-Day: June 6, 1944: The Climatic Battle of World War II by 3 Stephen Ambrose and Twenty-Five Yards of War: The Extraordinary Courage of Ordinary 4 Men in World War II by Ronald J. Drez; and 5 WHEREAS, Sergeant John Ray proudly and devoutly served his country; his 6 heroism and sacrifice, although hidden in shadows of time, deserve universal recognition and 7 unflagging gratitude; and 8 WHEREAS, Sergeant John Ray merits a sincere measure of posthumous 9 commendation for his achievements and contributions as a sergeant in the United States 10 Army and an exceptional son, brother, husband, and citizen. 11 THEREFORE, BE IT RESOLVED that the House of Representatives of the 12 Legislature of Louisiana does hereby express its sincerest gratitude to Sergeant John Ray 13 and commends him for his great service to America and his unselfish military heroism and 14 does hereby recognize and extend sincere appreciation to Sergeant John Ray's widow, Paula 15 F.
