HOUSE RESOLUTION NO. 168

AGRICULTURE/FOREST DEPT: Urges and requests the Department of Agriculture to study the economic impact of current and potential rules and regulations regarding forest crops

1	A RESOLUTION
2	To urge and request the Department of Agriculture to study the economic impact of current
3	and potential rules and regulations regarding forest crops, including but not limited
4	to statutory provisions and local ordinances.
5	WHEREAS, forest crops are the number one agricultural commodity in Louisiana,
6	with an economic value of \$3.6 billion; and
7	WHEREAS, the forest products industry is Louisiana's second largest manufacturing
8	employer, with over nine hundred firms in forty-five parishes directly employing over
9	twenty-five thousand people; and
10	WHEREAS, an additional eight thousand people are employed in the harvesting and
11	transportation of forest crops; and
12	WHEREAS, forest land owners currently pay timber severance taxes and property
13	taxes as provided for in Article VII, Section (4)(B) and Article VII, Section (18)(C) of the
14	Constitution of Louisiana; and
15	WHEREAS, seventy-five percent of the timber severance tax is remitted to the
16	governing authority of the parish in which severance or production occurs and may be used
17	to repair roads utilized by companies harvesting and transporting forest crops in the parish;
18	and

1 WHEREAS, in addition to property and severance taxes, some parishes further 2 require forest land owners and companies harvesting and transporting forest crops to pay 3 road bonds and permit fees; and 4 WHEREAS, parishes requiring companies harvesting and transporting forest crops to purchase additional liability bonds and certificates of insurance and permit fees for 5 6 hauling trucks can act as a deterrent for companies to perform work in the parish; and 7 WHEREAS, the combination of these taxes and fees creates a potentially disastrous 8 effect on the forest industry's ability to operate, create jobs, and generate revenue for local 9 governments and the state. 10 THEREFORE, BE IT RESOLVED that the House of Representatives of the 11 Legislature of Louisiana does hereby request the Department of Agriculture to study the 12 economic impact of current and potential rules and regulations regarding forest crops, 13 including but not limited to statutory provisions and local ordinances which create or 14 increase bond requirements and permit fees, and submit a report of its findings and 15 recommendations to the House of Representatives of the Legislature of Louisiana no later 16 than February 1, 2019. 17 BE IT FURTHER RESOLVED that a copy of this Resolution be transmitted to the 18 commissioner of the Department of Agriculture.
