A RESOLUTION

2	To commend the Baton Rouge District Nurses Association upon the historic occasion of its
3	one hundredth anniversary.
4	WHEREAS, when the Baton Rouge District Nurses Association (BRDNA) was
5	organized in 1918 and was known at that time as the Baton Rouge Graduate Nurses
6	Association; the association came to fruition as a response to an influenza epidemic with the
7	goals of ensuring fully trained and qualified nurses were practicing in the Baton Rouge
8	community and standardizing the costs of private duty nursing services; and
9	WHEREAS, the goals of the BRDNA remain consistent with those established by
10	their founders and early nursing champions; one hundred years later, nurses remain at the
11	forefront of advocating for patients, responding to community needs, and promoting
12	professional growth and development; and
13	WHEREAS, the BRDNA serves the capital region parishes of Ascension, East Baton
14	Rouge, Iberville, Livingston, Pointe Coupee, St. Helena, and West Baton Rouge; and
15	WHEREAS, the professional nursing organization fosters high standards of nursing
16	while working to improve health standards and access to health care for Louisianians; and
17	WHEREAS, the BRDNA is an affiliate professional nursing organization of the
18	Louisiana State Nurses Association and the American Nurses Association; and
19	WHEREAS, from bedside nursing in hospitals and long-term care facilities to the
20	halls of research institutions, state legislatures, and congress, the depth and breadth of the
21	nursing profession continues to meet the expanding needs of American society; and

2	measure of commendation as their remarkable dedication to the health and well-being of
3	their neighbors and fellow community members is celebrated during the one hundredth
