SENATE RESOLUTION NO. 195

BY SENATOR MORRELL

FLOOD PROTECTION AUTH. Expresses the intent of the Louisiana Senate that only district members of the New Orleans City Council in whose district a non-flood asset is located shall appoint a member to the Non-Flood Protection Asset Management Authority.

1 A RESOLUTION

2 To express the intent of the Louisiana Senate that only members of the New Orleans City
3 Council who represent a New Orleans City Council district in whose district a non-
4 flood asset is located shall appoint a member to the Non-Flood Protection Asset
5 Management Authority.

6 WHEREAS, the New Orleans City Council has five members who represent council
7 districts A, B, C, D, and E and two members who are council members at large; and

8 WHEREAS, the Legislature of Louisiana enacted R.S. 38:330.12.1 that creates the
9 Non-Flood Protection Asset Management Authority as a political subdivision to manage,
10 control, regulate, operate, and maintain any non-flood protection facility or improvement
11 asset or function within a levee district within the jurisdiction of a flood protection authority;
12 and

13 WHEREAS, the introductory paragraph of R.S. 38:330.12.1(C) provides that the
14 Non-Flood Protection Asset Management Authority shall be composed of certain members
15 who shall be subject to Senate confirmation, provided that no elected official shall be
16 appointed to serve as a member of the authority; and

17 WHEREAS, R.S. 38:330.12.1(C)(4) provides for the appointment of one member to
18 the Non-Flood Protection Asset Management Authority by each New Orleans City Council

1 member in whose district a non-flood asset is located; and

2 WHEREAS, R.S. 38:330.12.1(C)(4) does not provide for the appointment of a
3 member to the Non-Flood Protection Asset Management Authority by any New Orleans City
4 Council member who serves as a council member at large.

5 THEREFORE, BE IT RESOLVED that the Louisiana Senate does hereby express
6 its specific intent that R.S. 38:330.12.1(C)(4) authorizes only a member of the New Orleans
7 City Council who represents a New Orleans City Council district in whose district a non-
8 flood asset is located to appoint a member to the Non-Flood Protection Asset Management
9 Authority.

10 BE IT FURTHER RESOLVED that the Louisiana Senate does hereby express its
11 specific intent that R.S. 38:330.12.1(C)(4) does not authorize the appointment of a member
12 to the Non-Flood Protection Asset Management Authority by any member of the New
13 Orleans City Council who serves as a council member at large.

14 BE IT FURTHER RESOLVED that a copy of this Resolution be transmitted to each
15 member of the New Orleans City Council.
