Amendments proposed by House Committee on House and Governmental Affairs to Engrossed Senate Bill No. 319 by Senator Gatti

1 AMENDMENT NO. 1

2 On page 1, line 2, after "to repeal" and before "R.S. 33:4579" insert "Chapter 21 of Title 17  
3 of the Louisiana Revised Statutes of 1950, comprised of R.S. 17:3051 through 3060,"

4 AMENDMENT NO. 2

5 On page 1, line 6, delete "36:109(U)," and insert "36:109(U) and 651(D)(10),"

6 AMENDMENT NO. 3

7 On page 2, line 1, after "duties of the" and before "St." insert "Health Education Authority  
8 of Louisiana,"

9 AMENDMENT NO. 4

10 On page 4, after line 13, insert the following:

11 **"Health Education Authority of Louisiana**

12 Section 12.(A) The commissioner of administration, notwithstanding any  
13 other provision of law to the contrary, is hereby authorized and empowered to  
14 convey, transfer, assign, lease or deliver the interest the state has to all or any portion  
15 of the following described parcel of property to the state of Louisiana from the  
16 Health Education Authority of Louisiana, a body corporate and public, constituting  
17 an instrumentality of the state of Louisiana:

18 The parking garage located at 300 Lasalle Street, New Orleans,  
19 Louisiana which parking garage is bounded by Lasalle Street, Gravier Street,  
20 Perdido Street, and Duncan Plaza, in the Parish of Orleans, Louisiana, and  
21 all of the equipment, vehicles, supplies, books, records, documents, papers,  
22 monies, actions, or any other item of property, and the improvements  
23 thereon, both movable and immovable, heretofore owned, held, used,  
24 operated, or maintained by the Health Education Authority of Louisiana.

25 (B) The commissioner of administration is hereby authorized to enter into  
26 such documents, contracts, agreements, covenants, conditions, stipulations, or other  
27 instruments and to execute such documents as necessary to properly effectuate any  
28 conveyance, transfer, assignment, lease, or delivery of title, to the property described  
29 in Subsection A of this Section. The commissioner of administration is hereby  
30 granted the right, power, and authority to do, perform, and exercise for and on behalf  
31 of the Health Education Authority of Louisiana all of the executive and  
32 administrative functions provided for by the constitution or laws with respect to the  
33 Health Education Authority of Louisiana with respect to the property described in  
34 Subsection A of this Section, including the right to do, perform, and exercise for and  
35 on behalf of the authority all acts and things required to be done and performed in  
36 connection with the authorization and issuance of revenue bonds by the authority,  
37 and the powers, duties, functions, and responsibilities shall be transferred to the  
38 commissioner of administration as provided in Part IV of Chapter 22 of Title 36 of  
39 the Louisiana Revised Statutes of 1950, as amended, which provisions shall be  
40 applicable to the authority and to the property described in Subsection A of this  
41 Section in order to effectuate the purposes of this Section.

42 Section 13.(A) Chapter 21 of Title 17 of the Louisiana Revised Statutes of  
43 1950, comprised of R.S. 17:3051 through 3060, is hereby repealed.

44 (B) R.S. 36:651(D)(10) is hereby repealed.

1                   Section 14.(A) The provisions of this Section and Sections 1 through 12 of  
2 this Act shall become effective on August 1, 2018.  
3                   (B) The provisions of Section 13 of this Act shall become effective on  
4 November 1, 2018."
