

1 WHEREAS, over the next forty years, the zoo became a year-round family attraction
2 and vital economic driver in north Baton Rouge with more than a quarter million annual
3 visitors of all ages and backgrounds; and

4 WHEREAS, over the last several years, although BREC receives millions of dollars
5 in funding annually from local property taxes, the facilities at the Baton Rouge Zoo have
6 fallen into disrepair, the number of visitors has declined significantly, and the zoo recently
7 lost its accreditation; and

8 WHEREAS, BREC contends that the zoo cannot survive at its current location and
9 has made a recent push to move the zoo to the Baton Rouge fairgrounds in the southern part
10 of the parish, arguing that a state-of-the-art zoo can be developed at that location which will
11 result in an additional one hundred twenty-five thousand annual visitors; and

12 WHEREAS, the Baton Rouge fairgrounds, which are comprised of one hundred
13 thirty-three acres, were inundated with significant floodwaters during the August 2016 flood
14 and are susceptible to future flooding, which poses a potential threat to all animals that
15 would be housed at that location; and

16 WHEREAS, the zoo currently sits on only a tiny portion of the sprawling six hundred
17 acres of Greenwood Park which provides ample room for the expansion of zoo facilities on
18 property that did not flood during the August 2016 flood.

19 THEREFORE, BE IT RESOLVED that the House of Representatives of the
20 Legislature of Louisiana does hereby create the Task Force on Recreation and Park
21 Commission for the Parish of East Baton Rouge Policies to study issues related to the
22 operation, management, funding, and location of the Baton Rouge Zoo and to provide for
23 a written report of findings and recommendations to the House Committee on Municipal,
24 Parochial and Cultural Affairs not later than December 31, 2018.

25 BE IT FURTHER RESOLVED that the task force shall be composed of the
26 following members:

27 (1) The state representative for House District No. 63.

28 (2) The state representative for House District No. 29.

29 (3) The mayor-president of the city of Baton Rouge and parish of East Baton Rouge
30 or his designee.

- 1 (4) The mayor of the city of Baker or his designee.
- 2 (5) The mayor of the city of Central or his designee.
- 3 (6) The mayor of the city of Zachary or his designee.
- 4 (7) The member of the governing authority of the city of Baton Rouge and parish
5 of East Baton Rouge who represents Council District No. 2.
- 6 (8) A member of the Recreation and Park Commission for the Parish of East Baton
7 Rouge designated by the superintendent of the commission.
- 8 (9) A practicing veterinarian designated by the state representative for House District
9 No. 63.
- 10 (10) A representative of Keep the Baton Rouge Zoo at Greenwood Park designated
11 by the state representative for House District No. 63.
- 12 (11) A member of the governing board of the Baton Rouge North Economic
13 Development District designated by the governing board.
- 14 BE IT FURTHER RESOLVED that the state legislators serving on the task force
15 shall call its first meeting, at which the members shall elect a chairman and take other
16 organizational actions as they deem appropriate.
- 17 BE IT FURTHER RESOLVED that the task force may request administrative
18 support from any state or local entity.
