In all litigation whereby a state agency, board or commission, including 27 levee boards, appoints, employs, or contracts private legal counsel to represent the 28 state or a state agency, board or commission, including levee boards, pursuant to R.S. 29 39:1538, R.S. 42:262, or R.S. 49:258, or Subsection E of this Section, the secretary of the department, or the head of the state agency, or the board or commission, 30 31 including levee boards, shall consistently maintain accurate data on legal contracts, 32 legal costs, and all final judgments, all of which shall be reported to the attorney general. The report shall be in writing or submitted electronically, as determined by 33 34 the attorney general, and submitted to the attorney general quarterly. The attorney 35 general shall prepare and submit an annual report to the legislature no later than the first day of the regular session and shall submit quarterly updates of the report to the 36 37 division of administration, the Senate Committee on Finance, the House Committee
