2	To enact R.S. 49:191(10)(c) and to repeal R.S. 49:191(8)(n), relative to the Governor's
3	Office of Homeland Security and Emergency Preparedness, including provisions to
4	provide for the re-creation of the Governor's Office of Homeland Security and
5	Emergency Preparedness and the statutory entities made a part of the department by
6	law; to provide for the effective termination date for all statutory authority for the
7	existence of such statutory entities; and to provide for related matters.
8	Be it enacted by the Legislature of Louisiana:
9	Section 1. Pursuant to R.S. 49:193, the Governor's Office of Homeland Security and
10	Emergency Preparedness and the statutory entities made a part of the department by law
11	shall be re-created effective June 30, 2018, and all statutory authority therefor is continued
12	in accordance with the provisions of Part XII of Chapter 1 of Title 49 of the Louisiana
13	Revised Statutes of 1950.
14	Section 2. All statutory authority for the existence of the Governor's Office of
15	Homeland Security and Emergency Preparedness and the statutory entities made a part of
16	the department as re-created by Section 1 of this Act shall cease as of July 1, 2023, pursuant
17	to R.S. 49:191. However, the Governor's Office of Homeland Security and Emergency
18	Preparedness may be re-created prior to such date in accordance with the provisions of Part
19	XII of Chapter 1 of Title 49 of the Louisiana Revised Statutes of 1950.
20	Section 3. The provisions of R.S. 49:193 are hereby superseded to the extent that
21	those provisions are in conflict with the provisions of this Act.
22	Section 4. R.S. 49:191(10)(c) is hereby enacted to read as follows:
23	§191. Termination of legislative authority for existence of statutory entities;
24	phase-out period for statutory entities; table of dates

Notwithstanding any termination dates set by any previous Act of the 1 2 legislature, the statutory entities set forth in this Section shall begin to terminate their 3 operations on July first of each of the following years, and all legislative authority 4 for the existence of any statutory entity, as defined in R.S. 49:190, shall cease as of 5 July first of the following year, which shall be the termination date: 6 7 (10) July 1, 2022: 8 9 (c) The Governor's Office of Homeland Security and Emergency 10 Preparedness and all statutory entities made a part of the department by law. 11 Section 5. R.S. 49:191(8)(n) is hereby repealed. 12 Section 6. This Act shall become effective on June 30, 2018; if vetoed by the 13 governor and subsequently approved by the legislature, this Act shall become effective on 14 June 30, 2018, or on the day following such approval by the legislature, whichever is later.
