HOUSE SUMMARY OF SENATE AMENDMENTS

HCR 85 2018 Regular Session Magee

ALCOHOLIC BEVERAGES: Creates a task force to study issues associated with the delivery of alcoholic beverages by third party companies in this state

Synopsis of Senate Amendments

- 1. Increases the number of task force members from 11 members to 19 members.
- 2. The following members were added:
 - (a) The secretary of the Department of Economic Development, or his designee.
 - (b) The chair of the House Committee on Commerce, or his designee.
 - (c) The chair of the Senate Committee on Commerce, Consumer Protection, and International Affairs, or his designee.
 - (d) The executive director of the Louisiana Association of Business and Industry, or his designee.
 - (e) The executive director of the Louisiana Sheriffs' Association, or his designee.
 - (f) The executive director of the Louisiana Craft Brewers Guild, or his designee.
 - (g) A representative of a Louisiana registered third-party platform provider who provides an e-commerce platform and operational resources for restaurants.
 - (h) A representative of a Louisiana registered third-party platform provider who provides an e-commerce platform and operational resources for grocery stores.
- 3. Requires five members of the task force to constitute a quorum and requires the task force to meet monthly at the state capitol starting July 1, 2018.
- 4. Requires the staff of the Senate Committee on Judiciary B to be the staff for the task force.
- 5. Requires the task force to submit a final report of its findings and recommendations to the governor, chairman of the House Judiciary Committee, and the chairman of the Senate Committee on Judiciary B no later than March 8, 2019.

Digest of Bill as Finally Passed by Senate

Creates the Louisiana Alcohol Delivery Task Force to study the potential issues of allowing third party companies to deliver alcoholic beverages by third party companies and to recommend any action or legislation.

The task force shall consist of the following 19 members:

- (1) The commissioner of alcohol and tobacco control, or her designee, who shall serve as the chairperson of the task force.
- (2) The secretary of the Department of Economic Development, or his designee.
- (3) The speaker of the House of Representatives, or his designee.
- (4) The president of the Senate, or his designee.
- (5) The chair of the Senate Committee on the Judiciary B, or his designee.
- (6) The chair of the House Judiciary Committee, or his designee.

- (7) The chair of the House Committee on Commerce. or his designee.
- (8) The chair of the Senate Committee on Commerce, Consumer Protection, and International Affairs, or his designee.
- (9) The executive director of the Louisiana Association of Business and Industry, or his designee.
- (10) The executive director of the Louisiana Sheriffs' Association, or his designee.
- (11) The executive director of the Louisiana Municipal Association, or his designee.
- (12) The executive director of the Louisiana Oil Marketers and Convenience Store Association, or his designee.
- (13) The executive director of the Beer Industry League of Louisiana Inc., or his designee.
- (14) The executive director of the Wine and Spirits Foundation of Louisiana, or his designee.
- (15) The executive director of the Louisiana Craft Brewers Guild, or his designee.
- (16) The president of the Louisiana Restaurant Association, or his designee.
- (17) The president of the Louisiana Retailers Association, or his designee.
- (18) A representative of a Louisiana registered third-party platform provider who provides an e-commerce platform and operational resources for restaurants.
- (19) A representative of a Louisiana registered third-party platform provider who provides an e-commerce platform and operational resource for grocery stores.

Requires the task force to prepare and submit a final report to the governor, chair of the House Judiciary Committee, and the Senate Committee on Judiciary B no later than March 8, 2019.

The task force shall meet monthly starting July 1, 2018.
