 Provides relative to funding for university laboratory schools

**Present law** provides that an elementary and secondary school operated by a public postsecondary institution (lab school) is considered part of the parish school system for the purpose of inclusion in the minimum foundation program (MFP) funding formula. Requires the Department of Education to allocate funds to the postsecondary institution which shall allocate the funds for the operation of the lab school. Recognizes lab schools at LSU A&M and Southern A&M. **Proposed law** provides for a lab school at the University of Louisiana at Lafayette (ULL).

**EXPENDITURE EXPLANATION**

There is no anticipated direct material effect on governmental expenditures as a result of this measure. MFP funds currently allocated to the Lafayette Parish School District will be redirected to ULL (through an Interagency Transfer) for operations of the school. The amount is indeterminable and will depend upon the enrollment of students at the lab school and the number who come from surrounding public schools. There could be an increase in MFP funding to the extent students transfer from private schools, however no such projections exist at this time. Lab schools receive the state MFP allocation of the parish in which they are located but are not allocated the per pupil amount from local revenues; lab schools are authorized to assess tuition charges pursuant to 17:3351(A)(5); 17:1855.2; Act 991 of 1999 as amended by Act 214 of 2004.

ULL proposes converting/renovating existing infrastructure for use as the lab school and is still in the planning stage, including consideration on the potential use of temporary facilities. No state funds have been requested for the construction of the school. The first year of operation has not been finalized but would not occur prior to Fall 2019 (FY20). Enrollment and expansion projections are identified below.
