2	To amend and reenact R.S. 14:95(K), relative to the carrying of concealed weapons; to
3	provide relative to the crime of illegal carrying of weapons; to provide for exceptions
4	for certain former members of the legislature; and to provide for related matters.
5	Be it enacted by the Legislature of Louisiana:
6	Section 1. R.S. 14:95(K) is hereby amended and reenacted to read as follows:
7	§95. Illegal carrying of weapons
8	* * *
9	K.(1) The provisions of this Section shall not prohibit a retired justice or
10	judge of the supreme court, courts of appeal, district courts, parish courts, juvenile
11	courts, family courts, city courts, retired attorney general, retired assistant attorneys
12	general, retired district attorneys, and retired assistant district attorneys, and former
13	members of either house of the legislature from possessing and concealing a handgun
14	on their person provided that such retired person or former member of the legislature
15	is qualified annually, at their expense, in the use of firearms by the Council on Peace
16	Officer Standards and Training and has on their person valid identification showing
17	proof of their status as a former member of the legislature or as a retired justice,
18	judge, attorney general, assistant attorney general, district attorney, or assistant
19	district attorney. For a former member of the legislature, the valid identification
20	showing proof of status as a former legislator required by the provisions of this
21	Paragraph shall be a legislative badge issued by the Louisiana Legislature that shall
22	include the former member's name, the number of the district that the former
23	member was elected to represent, the years that the former member served in the

legislature, and words that indicate the person's status as a former member of the legislature.

3 (2) The retired justice, judge, attorney general, assistant attorney general, 4 district attorney, or assistant district attorney or former member of the legislature 5 shall be qualified annually in the use of firearms by the Council on Peace Officer 6 Standards and Training and have proof of qualification. However, this Subsection 7 shall not apply to a retired justice, judge, attorney general, assistant attorney general, 8 district attorney, or assistant district attorney or to a former member of the legislature 9 who is medically retired based upon any mental impairment, or who has entered a 10 plea of guilty or nolo contendere to or been found guilty of a felony offense. For the 11 purposes of this Subsection, "retired district attorney" or "retired assistant district 12 attorney" shall mean a district attorney or an assistant district attorney receiving 13 retirement benefits from the District Attorneys' Retirement System.
