1 before any court on the effective date of this Act and all documents involved in or
2 affected by said legal proceeding, shall retain their effectiveness and shall be
3 continued in the name of the former agency. All further legal proceedings and
4 documents in the continuance, disposition, and enforcement of said legal proceedings
5 shall be in the name of the original party agency, and the state Department of
6 Education shall be substituted for the original party agency without the necessity for
7 amendment or any document to substitute the name of the department or the name
8 or title of any subdivision or section of the department. For purposes of this Section,
9 "document" shall be defined as provided in R.S. 36:924.

10 Section 6. All employees heretofore engaged in the performance of functions
11 of the Louisiana Environmental Education Commission, to the extent the state
12 superintendent of education deems necessary to carry out the functions formerly
13 performed, shall insofar as practicable and necessary continue to perform the duties
14 heretofore performed, subject to applicable state civil service laws, rules, and
15 regulations."
