Amendments proposed by House Committee on Ways and Means to Original House Bill No. 521 by Representative Abramson

1 AMENDMENT NO. 1

2 On page 1, line 2, after "reenact" delete the remainder of the line in its entirety and delete
3 line 3 in its entirety and insert the following:

4 "R.S. 21:204(A) and to enact R.S. 47:338.220, relative to New Orleans; to provide"

5 AMENDMENT NO. 2

6 On page 1, line 4, after "organizations;" delete the remainder of the line in its entirety and
7 delete line 5 in its entirety and insert "to provide for the amount of the hotel assessment; to
8 authorize the governing"

9 AMENDMENT NO. 3

10 On page 1, line 7, after "proceeds;" delete the remainder of the line in its entirety and at the
11 beginning of line 8, delete "referendum of assessed hotels;"

12 AMENDMENT NO. 4

13 On page 1, line 13, after "Section 1." and before "hereby" delete "R.S. 21:202 and 204(A),
14 (B), and (D) are" and insert "R.S. 21:204(A) is"

15 AMENDMENT NO. 5

16 On page 1, delete lines 15 through 20 in their entirety and on page 2, delete lines 1 through
17 4 in their entirety

18 AMENDMENT NO. 6

19 On page 2, line 6, after "A.(1)" and before "tourism" delete "A" and insert "Except as
20 provided for in Paragraph (2) of this Subsection, a"

21 AMENDMENT NO. 7

22 On page 2, line 7, after "assessment" and before "on" insert "of up to one and ~~three quarters~~
23 one-half percent ~~of~~"

24 AMENDMENT NO. 8

25 On page 2, at the end of line 12, insert the following:

26 "and ratified by a vote of the assessed hotels in a referendum conducted in
27 accordance with R.S. 21:206"

28 AMENDMENT NO. 9

29 On page 2, delete lines 14 through 29 in their entirety and on page 3, delete lines 1 through
30 4 in their entirety and insert the following:

31 "(2) Beginning January 1, 2021, the maximum amount of the hotel
32 assessment authorized pursuant to the provisions of Paragraph (1) of this Subsection

1 shall not exceed one and twenty- five hundredths of one percent on the daily room
2 charge."

3 AMENDMENT NO. 10

4 On page 3, at the end of line 10, insert the following:

5 "Until December 31, 2020, the rate of the tax authorized by this Section shall not
6 exceed twenty-five hundredths of one percent of the rent or fee charged for
7 occupancy. Beginning January 1, 2021, the rate of the tax authorized by this Section
8 shall not exceed one-half of one percent of the rent or fee charged for occupancy."

9 AMENDMENT NO. 11

10 On page 3, delete lines 22 through 24 in their entirety and at the beginning of line 25 delete
11 "C." and insert "B."

12 AMENDMENT NO. 12

13 On page 4, at the beginning of line 4, delete "D." and insert "C."

14 AMENDMENT NO. 13

15 On page 4, at the beginning of line 10, delete "E. Except as provided in Subsection D" and
16 insert "D. Except as provided in Subsection C"

17 AMENDMENT NO. 14

18 On page 4, delete line 12 in its entirety and at the beginning of line 13, delete "Section 4."
19 and insert "Section 3."
