**10** "(5)" to "(4)"**11** AMENDMENT NO. 5**12** On page 8, delete line 15, and insert the following:**13** "(1) Properly completed application forms provided by the board."**14** AMENDMENT NO. 6**15** On page 8, at the end of line 28, delete the period "." and insert "or its equivalent issued by  
**16** the local governing authority."**17** AMENDMENT NO. 7**18** On page 9, between lines 11 and 12 insert the following:**19** "(13) A notarized affidavit stating that neither the owner or solicitor  
**20** has pleaded guilty to a felony or has been found guilty of a felony."**21** AMENDMENT NO. 8**22** On page 9, at the beginning of line 12, change "(13)" to "(14)"**23** AMENDMENT NO. 9**24** On page 9, line 16, after "(2)(a)" delete the remainder of the line and delete line 17 and insert  
**25** "Financial statements of the school prepared by an independent certified public accountant  
**26** for the previous business year."**27** AMENDMENT NO. 10**28** On page 9, after line 29, insert the following:**29** "(8) Properly completed application forms provided by the board."

4 On page 22, after line 27, insert the following:

5 "J. The board shall adopt necessary rules and regulations based on  
 6 recommendations from the commission providing for the cessation of  
 7 payments into the Student Protection Fund by schools licensed under the  
 8 provisions of this Chapter upon the fund balance reaching a minimum of  
 9 eight hundred thousand dollars and for the resumption of payments into the  
 10 fund whenever the fund balance is less than seven hundred fifty thousand  
 11 dollars.

12 K.(1) Notwithstanding the provisions of Subsection A of this  
 13 Section, there is hereby established a special account within the Proprietary  
 14 School Student Protection Fund to be known as the Proprietary School  
 15 Student Records and Administration Account, hereafter in this Subsection  
 16 referred to as the "administration account". Any balance in the Student  
 17 Protection Fund on July 1, 2000, that exceeds eight hundred thousand dollars,  
 18 as provided in Subsection F of this Section, shall be deposited into the  
 19 administration account. All interest earned on the fund after July 1, 2000,  
 20 shall be deposited in the administration account. All deposits made to the  
 21 Student Protection Fund after July 1, 2000, shall be made in accordance with  
 22 the provisions of this Section.

23 (2) Amounts from the administration account shall be pledged and  
 24 dedicated solely and exclusively for costs associated with board functions as  
 25 they relate to the administration of proprietary schools and for the creation  
 26 of a digital student records management system."
