Amendments proposed by Senator Fannin to Engrossed Senate Bill No. 149 by Senator Luneau

1 AMENDMENT NO. 1

2 On page 7, between lines 21 and 22, insert the following:

3 **"Section 4. The commissioner of administration and the secretary of the**  
4 **Department of Children and Family Services, notwithstanding any other**  
5 **provision of law to the contrary, are hereby authorized and empowered to**  
6 **convey, transfer, assign, lease, or deliver any interest, excluding mineral rights,**  
7 **the state may have to all or any portion of the following described parcel of**  
8 **property to the Jackson Parish Police Jury:**

9 **Beginning at the Northeast corner of the SE1/4 of SE1/4 of Section 32,**  
10 **Township 15 North boundary line of said forty 525 feet, thence run**  
11 **South 414 feet, thence run east 525 feet or to the East boundary line of**  
12 **said forty, thence run North 414 feet or to the point of beginning,**  
13 **together with all improvements and appurtenances thereunto belonging,**  
14 **situated in Jackson Parish, Louisiana."**

15 AMENDMENT NO. 2

16 On page 7, line 22, change "**Section 4.**" to "**Section 5.**"

17 AMENDMENT NO. 3

18 On page 8, line 3, change "**Section 5.**" to "**Section 6.**"

19 AMENDMENT NO. 4

20 On page 8, line 13, change "**Section 6.**" to "**Section 7.**"

21 AMENDMENT NO. 5

22 On page 8, between lines 22 and 23, insert the following:

23 **"Section 8. The commissioner of administration and the secretary of the**  
24 **Department of Children and Family Services, on behalf of the state of**  
25 **Louisiana, are hereby authorized to enter into such agreements, covenants,**  
26 **conditions, and stipulations and to execute such documents as necessary to**  
27 **properly effectuate any conveyance, transfer, assignment, lease, or delivery of**  
28 **title, excluding mineral rights, to the property described in Section 4, and as**  
29 **more specifically described in any such agreements entered into and documents**  
30 **executed by and between the commissioner of administration and the secretary**  
31 **of the Department of Children and Family Services and the Jackson Parish**  
32 **Police Jury, in exchange of consideration at least proportionate to the appraised**  
33 **value of the property."**

34 AMENDMENT NO. 6
