
HOUSE COMMITTEE AMENDMENTS

2019 Regular Session

Amendments proposed by House Committee on Ways and Means to Original House Bill No. 601 by Representative Bagley

1 AMENDMENT NO. 1

2 On page 1, line 2, after "tax;" delete the remainder of the line in its entirety and insert "to
3 levy an annual"

4 AMENDMENT NO. 2

5 On page 1, line 3, after "tax;" delete the remainder of the line in its entirety and delete line
6 4 in its entirety and insert the following:

7 "to provide for the collection and remittance of the tax; to provide for the disposition
8 and use of the avails of the tax; to require the promulgation of rules and regulations;
9 to provide for an effective date;"

10 AMENDMENT NO. 3

11 On page 1, at the beginning of line 9, delete "A." and insert "A.(1)"

12 AMENDMENT NO. 4

13 On page 1, line 10, after "R.S. 47:463," delete the remainder of the line in its entirety and
14 delete lines 11 through 20 in their entirety and insert the following:

15 "there is hereby levied an annual inspection tax of ten dollars on all motor vehicles
16 not required to obtain a certificate of inspection pursuant to the provisions of R.S.
17 32:1301 through 1306. The commissioner of motor vehicles shall collect the tax
18 levied pursuant to the provisions of this Section every two years at the same time and
19 in the same manner as the registration license tax pursuant to the provisions of R.S.
20 47:463 and shall remit the taxes to the state treasurer.

21 (2) After compliance with the requirements of Article VII, Section 9(B) of
22 the Constitution of Louisiana relative to the Bond Security and Redemption Fund,
23 and after a sufficient amount is allocated from that fund to pay all of the obligations
24 secured by the full faith and credit of the state which become due and payable within
25 any fiscal year, the legislature shall annually appropriate and the state treasurer shall
26 annually transfer an amount equal to the avails of the tax collected pursuant to the
27 provisions of this Section to the Department of Public Safety and Corrections. The
28 Department of Public Safety and Corrections shall disburse the avails of the tax as
29 follows:

30 (a) An amount equal to one dollar and twenty-five cents of the avails of each
31 annual inspection tax collected pursuant to the provisions of this Section shall be
32 transferred to the office of motor vehicles.

33 (b) The remainder of the avails of the tax collected pursuant to the provisions
34 of this Section shall be transferred to the office of state police and shall be used as
35 follows:

36 (i) An amount equal to four dollars of the avails of each annual inspection
37 tax collected pursuant to the provisions of this Section to be used for the training of
38 state police officers.

1 (ii) An amount equal to four dollars and seventy-five cents of the avails of
2 each annual inspection tax collected pursuant to the provisions of this Section to be
3 used for traffic enforcement.

4 B. The commissioner of motor vehicles shall promulgate rules and
5 regulations in accordance with the Administrative Procedure Act to implement the
6 provisions of this Section, including rules necessary for the collection and remittance
7 of the tax to the treasurer."
