HOUSE FLOOR AMENDMENTS

2019 Regular Session

Amendments proposed by Representative Crews to Engrossed House Bill No. 132 by Representative Crews

1 AMENDMENT NO. 1

2 On page 1, at the beginning of line 3, change "32:681(E)" to "32:681(E) and (F)"

3 AMENDMENT NO. 2

4 On page 1, line 8, change "R.S. 32:681(E) is" and "R.S. 32:681(E) and (F) are"

5 AMENDMENT NO. 3

6 On page 1, at the end of line 9, change "serious bodily injury or" to "suspected serious injury
7 or"

8 AMENDMENT NO. 4

9 On page 1, at the beginning of line 13, change "a serious bodily injury or" to "a suspected
10 serious injury or"

11 AMENDMENT NO. 5

12 On page 2, line 3, change "serious bodily injury" to "suspected serious injury"

13 AMENDMENT NO. 6

14 On page 2, between lines 7 and 8, insert the following:

15 "E. For the purposes of this Section, the operator of any motor vehicle which
16 is involved in a collision or the operator of any watercraft involved in a collision,
17 crash, other casualty in which a suspected serious injury occurs, and the operator
18 does not receive a violation, that operator shall not be required to submit to a
19 chemical test or tests of his blood, urine, or other bodily substance for the purpose
20 of determining the presence of any abused substance or controlled dangerous
21 substance as set forth in R.S. 40:964 or any other impairing substance."

22 AMENDMENT NO. 7

23 On page 2, delete line 8 through 11 in their entirety and insert the following:

24 "F. For the purposes of this Section, "suspected serious injury", as provided
25 for in the Fourth Edition of the Model Minimum Uniform Crash Criteria Guideline,
26 means any injury other than fatal which results in any of the following:
27 (a) Severe laceration resulting in exposure of underlying tissues, muscle, or
28 organs, or resulting in a significant loss of blood.
29 (b) Broken or distorted extremity.
30 (c) Crash injuries.
31 (d) Suspected skull, chest, or abdominal injury other than bruises or minor
32 lacerations.

- 1 (e) Significant burns.
- 2 (f) Unconsciousness when taken from the crash scene.
- 3 (g) Paralysis.

4 AMENDMENT NO. 8

5 On page 2, after line 11, add the following:

6 "Section 2. The Department of Public Safety and Corrections is ordered to adopt
7 rules and regulations, including updating the Uniform Motor Vehicle Traffic Crash Report,
8 to implement the provisions of this Section.
