20 ~~lodging, or sleeping purposes to transient guests where such establishment consists~~
21 ~~of two or more guest rooms and does not encompass any hospital, convalescent or~~
22 ~~nursing home or sanitarium, or any hotel-like facility operated by or in connection~~
23 ~~with a hospital or medical clinic providing rooms exclusively for patients and their~~
24 ~~families. The word "hotel" used herein shall not include camp and retreat facilities~~
25 ~~owned and operated by nonprofit organizations exempt from federal income tax~~
26 ~~under Section 501(a) of the Internal Revenue Code as an organization described in~~
27 ~~Section 501(c)(3) of the Internal Revenue Code provided that the net revenue derived~~
28 ~~from the organization's property is devoted wholly to the nonprofit organization's~~
29 ~~purposes in this Section shall have the meaning provided in R.S. 47:301(6).~~

30 (ii) Notwithstanding any other provision of law to the contrary, the word
31 "hotel" as used in this Section shall not encompass any establishment consisting of
32 and operated solely as a facility zoned by local ordinance as workforce housing, or
33 any other similar type of establishment which is closed to and does not accept
34 reservations directly from individuals of the general public and which does not
35 market, solicit, advertise, or accept reservations through the use of any online
36 platform.
