DISTRICTS/CRIME PREVENT: Creates a crime prevention district in the Monticello neighborhood in East Baton Rouge Parish

| 6 | Notice of intention to introduce this Act has been published |
| 7 | as provided by Article III, Section 13 of the Constitution of |
| 8 | Louisiana. |
| 9 | Be it enacted by the Legislature of Louisiana: |
| 10 | Section 1. R.S. 33:9097.30 is hereby enacted to read as follows: |
| 11 | §9097.30. Monticello Crime Prevention and Improvement District |
| 12 | A. Creation. There is hereby created within the parish of East Baton Rouge, |
| 13 | as more specifically provided in Subsection B of this Section, a body politic and |
| 14 | corporate which shall be known as the Monticello Crime Prevention and |
| 15 | Improvement District, referred to in this Section as the "district". The district shall |
| 16 | be a political subdivision of the state as defined in the Constitution of Louisiana. |
| 17 | B. Boundaries. The district shall include the area within the following |
| 18 | boundaries: Commencing at the northwest corner of Monticello, 1st filing, being |
| 19 | located on the south right-of-way (ROW) line of Engineer Depot Canal; Thence |
| 20 | southerly along the west boundary of Monticello 1st filing, being a line generally |

| 12 | 34, Monticello; Thence northerly, westerly, and southerly along the boundaries of |
| 13 | Monticello, 4th filing, being the east boundary of Lot Z-7 and its southern extension, |
| 14 | the south ROW line of Canterbury Drive, and the west boundary of Lot Z-2 and its |
| 15 | southern extension to the south boundary of the Engineer Depot Canal; Thence |
| 16 | southwesterly along the south ROW line of the Engineer Depot Canal, being the |
| 17 | north boundary of Monticello, 1st filing, to the point of commencement. |
| 18 | C. Purpose. The district is established for the primary object and purpose of |
| 19 | promoting and encouraging the beatification, security, and overall betterment of the |
| 20 | district. |
| 21 | D. Governance. (1) The district shall be governed by a seven-member board |
| 22 | of commissioners, referred to in this Section as the "board". The board shall be |
| 23 | composed as follows: |
| 24 | (a) The president of the Monticello Citizens Association. |
| 25 | (b) The board of directors of the Monticello Citizens Association shall |
| 26 | appoint two members. |
| 27 | (c) The member of the Louisiana House of Representatives whose district |
| 28 | encompasses all or the greater portion of the area of the district shall appoint one |
| 29 | member. |

| 1 | (d) The member of the Louisiana Senate whose district encompasses all or | |

| 15 | (c) The member serving pursuant to Subparagraph (1)(a) of this Subsection | |
| 16 | shall serve during his term of office. | |
| 17 | (4) Any board member may be removed for cause by a majority vote of the | |
| 18 | board. | |
| 19 | (5) Vacancies shall be filled in the manner of the original appointment. A | |
| 20 | member shall be eligible for reappointment unless he was removed pursuant to | |
| 21 | Paragraph (4) of this Subsection. | |
| 22 | (6) All members of the board shall serve without compensation and shall not | |
| 23 | receive reimbursement for expenses. | |
| 24 | (7) The domicile of the board shall be within the district. | |
| 25 | (8) The board is authorized to adopt by laws for its governance and conduct. | |
| 26 | (9) The members of the board shall select from among themselves a | |
| 27 | president and such other officers as they deem appropriate whose responsibilities | |
| 28 | shall be as provided by the bylaws of the board. | |

| 11 | (3) To receive and expend funds collected pursuant to Subsection F of this | | |

| 14 | (4) To enter into contracts with individuals or entities, private or public. | | |

| 24 | F. Parcel fee. The governing authority of East Baton Rouge Parish may | | |

| 5 | (3) The owner of the parcel shall be responsible for payment of the fee. |
| 6 | (4)(a) The fee shall be imposed only after the question of its imposition has |
| 7 | been approved by a majority of the registered voters of the district voting on the |
| 8 | proposition at an election held for that purpose in accordance with the Louisiana |
| 9 | Election Code. |
| 10 | (b) The fee shall expire ten years after its initial levy but may be renewed if |
| 11 | approved by a majority of the registered voters of the district voting on the |
| 12 | proposition at an election as provided in Subparagraph (a) of this Paragraph. Any |
| 13 | election to authorize the renewal of the fee shall be held only at the same time as a |
| 14 | regularly scheduled election in the parish of East Baton Rouge. If the fee is renewed, |
| 15 | the term of the imposition of the fee shall be as provided in the proposition |
| 16 | authorizing such renewal, not to exceed ten years. |
| 17 | (5)(a) The sheriff of the parish of East Baton Rouge shall collect the fee at |
| 18 | the same time and in the same manner as ad valorem taxes are collected. |
| 19 | (b) The sheriff of the parish of East Baton Rouge shall remit to the district |
| 20 | all amounts collected not more than sixty days after collection; however, the board |
| 21 | may enter into an agreement with the sheriff to authorize the sheriff to retain a |
| 22 | collection fee. |
| 23 | (6) Any parcel fee shall be added to the tax rolls of the parish and shall be |
| 24 | enforced with the same authority and subject to the same penalties and procedures |
| 25 | as ad valorem taxes. |
| 26 | G. Budget. (1) The board of commissioners shall adopt an annual budget |
| 27 | in accordance with the Local Government Budget Act, R.S. 39:1301 et seq. |
| 28 | (2) The district shall be subject to audit by the legislative auditor pursuant |
| 29 | to R.S. 24:513. |

| 1 | H. Miscellaneous provisions. (1) It is the purpose and intent of this Section |

| 2 | that the additional law enforcement personnel and services provided by the district |
| 3 | shall be supplemental to and not in lieu of personnel and services provided in the |
| 4 | district by the city of Baton Rouge and East Baton Rouge Parish. |
| 5 | (2) If the district ceases to exist: |
| 6 | (a) All funds of the district shall be transmitted to the parish of East Baton |
| 7 | Rouge and shall be used for law enforcement purposes in the area included within |
| 8 | the district. |
| 9 | (b) The authority for the imposition of the parcel fee provided in this Section |
| 10 | shall cease. |
| 11 | Section 2. This Act shall become effective upon signature by the governor or, if not |
| 12 | signed by the governor, upon expiration of the time for bills to become law without signature |
| 13 | by the governor, as provided by Article III, Section 18 of the Constitution of Louisiana. If |
| 14 | vetoed by the governor and subsequently approved by the legislature, this Act shall become |
| 15 | effective on the day following such approval. |

Abstract: Creates the Monticello Crime Prevention and Improvement District in East Baton Rouge Parish. Provides for the district's boundaries, purpose, governance, and funding, including the authority to impose a parcel fee.

<u>Proposed law</u> creates the Monticello Crime Prevention and Improvement District in East Baton Rouge Parish for the purpose of promoting and encouraging the beautification, security, and betterment of the district. Provides for district boundaries.

<u>Proposed law</u> provides that the district shall be governed by a seven-member board of commissioners, all of whom shall be residents and qualified voters of the district, composed as follows:

- (1) The president of the Monticello Citizens Assoc. (association).
- (2) Two members appointed by the board of directors of the association.
- (3) One member appointed by the member of the La. House of Representatives whose district encompasses all or the greater portion of the area of the district.

- (4) One member appointed by the member of the La. Senate whose district encompasses all or the greater portion of the area of the district.
- (5) One member appointed by the member of the East Baton Rouge Parish Metro Council whose district encompasses all or the greater portion of the area of the district.
- (6) One member appointed by the mayor-president of East Baton Rouge.

<u>Proposed law</u> provides that members serve without compensation and without reimbursement of expenses.

Proposed law provides relative to the powers and duties of the district.

<u>Proposed law</u> authorizes the governing authority of the city of Baton Rouge, parish of East Baton Rouge, subject to voter approval, to impose and collect a parcel fee within the district. Provides that the amount of the fee shall not be more than \$100 per parcel per year. Requires that the fee be imposed on each parcel located within the district.

<u>Proposed law</u> defines "parcel" as a lot, a subdivided portion of ground, an individual tract, or a "condominium parcel" as defined in <u>present law</u> (R.S. 9:1121.103).

<u>Proposed law</u> provides that the fee shall expire 10 years after its initial levy but authorizes renewal of that fee. Provides that the term of the imposition of the fee shall be as provided in the proposition authorizing such renewal, not to exceed 10 years. Further provides that the fee shall be collected at the same time and in the same manner as ad valorem taxes and that any unpaid fee shall be added to the parish tax rolls and enforced with the same authority and subject to the same penalties and procedures as unpaid ad valorem taxes. Requires the sheriff to remit amounts collected to the district not later than 60 days after collection, but authorizes the board to enter into a contract with the sheriff authorizing the sheriff to retain a collection fee.

<u>Proposed law</u> provides that the district shall adopt an annual budget in accordance with <u>present law</u> (R.S. 39:1301 et seq.) and shall be subject to audit by the legislative auditor's office.

<u>Proposed law</u> provides that the intent of <u>proposed law</u> is to enhance the law enforcement personnel and services provided by the city and not to be in lieu of such services. Further provides that if the district ceases to exist, all of its funds shall be transmitted to the governing authority of the parish of East Baton Rouge and shall be used for law enforcement purposes in the area formerly comprising the district. Further provides that upon dissolution of the district, the authority to levy the parcel fee provided for in <u>proposed law</u> shall cease.

Effective upon signature of the governor or lapse of time for gubernatorial action.
