Amendments proposed by House Committee on House and Governmental Affairs to Engrossed Senate Bill No. 171 by Senator Hewitt

1 AMENDMENT NO. 1

2 On page 1, line 2, after "reenact" insert "R.S. 37:23.2 and"

3 AMENDMENT NO. 2

4 On page 1, line 4, after "mandates;" insert "to provide for exceptions; to provide relative to  
5 certain reports by certain licensing boards; to provide relative to certain notifications;"

6 AMENDMENT NO. 3

7 On page 1, between lines 5 and 6, insert the following:

8 "Section 1. R.S. 37:23.2 is hereby amended and reenacted to read as follows:

9 "§23.2. ~~Legislative report~~ **Reporting** requirements; notification requirements

10 A.(1) Each board or commission authorized to issue a license, permit, or  
11 certificate under this Title shall submit quarterly reports to the appropriate legislative  
12 oversight committees and to the ~~House Committee on House and Governmental~~  
13 ~~Affairs and the Senate Committee on Senate and Governmental Affairs~~ **division of**  
14 **administration**. The reports required by this Subsection shall contain:

15 (a) The number of complaints received regarding board actions or  
16 procedures.

17 (b) A summary of each such complaint and the disposition of each  
18 complaint.

19 (2) If any of the information required to be submitted pursuant to Paragraph  
20 (1) of this Subsection contains confidential, personally identifiable, or otherwise  
21 sensitive information, the board or commission shall clearly mark such information  
22 as confidential, personally identifiable, or sensitive information and the **officers and**  
23 **employees of the division of administration and the** legislative committees,  
24 members, and employees having access to the identified information shall not  
25 publicly disclose the information and shall protect the information from unauthorized  
26 use and disclosure.

27 B.(1) Each board or commission authorized to issue a license, permit, or  
28 certificate under this Title shall give notice to each applicant and licensee in or with  
29 each correspondence from the board or commission that the applicant or licensee  
30 may submit complaints about actions or procedures of the board or commission to  
31 the board or commission or directly to the ~~House Committee on House and~~  
32 ~~Governmental Affairs and the Senate Committee on Senate and Governmental~~  
33 ~~Affairs~~ **division of administration**.

34 (2) Each board or commission authorized to issue a license, permit, or  
35 certificate under this Title shall post a notice of the ability to submit complaints  
36 about the actions or procedures of the board or commission to the board or  
37 commission or to the ~~House Committee on House and Governmental Affairs and the~~  
38 ~~Senate Committee on Senate and Governmental Affairs~~ **division of administration**  
39 in a conspicuous place on the website of the board or commission.

40 (3) Each notice required by this Subsection shall contain at a minimum the  
41 mailing address, email address, and telephone number of the board or commission  
42 and the mailing address, email address, and telephone number of ~~each legislative~~  
43 ~~committee listed in Paragraph (2) of this Subsection~~ **the division of**  
44 **administration**."

5 **"F. The provisions of this Section shall not apply to any report required**
