Amendments proposed by House Committee on Appropriations to Engrossed House Bill No. 587 by Representative Marino

1 AMENDMENT NO. 1

2 On page 1, line 3, after "enact" delete the remainder of the line in its entirety and insert "R.S.
3 27:29.2.1, 92(D), 609, and 610, relative to the taxation of certain"

4 AMENDMENT NO. 2

5 On page 1, line 6, after "tax" and before the semi-colon ";" insert "and fees"

6 AMENDMENT NO. 3

7 On page 1, line 10, after "reenacted and" delete the remainder of the line in its entirety and
8 insert "R.S. 27:29.2.1, 92(D), 609, and 610 are hereby enacted to"

9 AMENDMENT NO. 4

10 On page 3, after line 28 insert the following:

11 "§92. Collection and disposition of fees

12 * * *

13 D.(1) There is hereby established in the state treasury a special subfund in the
14 Riverboat Gaming Enforcement Fund to be known as the "Sports Wagering
15 Enforcement Subfund", hereafter in this Section, the "subfund".

16 (2) The monies in the subfund shall be withdrawn only pursuant to
17 appropriation by the legislature and shall be used solely for the following:

18 (a) For the expenses of the Department of Public Safety and Corrections and
19 the Department of Justice, including regulatory, administrative, investigative,
20 enforcement, legal, and such other expenses as may be necessary to carry out the
21 provisions of this Chapter and Chapter 10 of this Title and the rules and regulations
22 of the board.

23 (b) For the expenses of the Louisiana Gaming Control Board for the
24 regulation of gaming activities authorized by Chapter 10 of this Title.

26 AMENDMENT NO. 5

27 On page 4, delete line 1 in its entirety and insert the following:

28 "§609. Sports wagering certificate fee"

29 AMENDMENT NO. 6

30 On page 4, line 9, after "this" delete the remainder of the line in its entirety and insert the
31 following:

1 "Section and those fees related to sports wagering activities in Chapter 1 of
2 this Title and deposit the fees into the Sports Wagering Enforcement Subfund as
3 established in R.S. 27:92(D)."

4 AMENDMENT NO. 7

5 On page 4, delete line 10 in its entirety and insert the following:

6 "§610. State tax; levy"

7 AMENDMENT NO. 8

8 On page 4, line 11, after "a" and before "percent" delete "fifteen" and insert "thirteen"

9 AMENDMENT NO. 9

10 On page 4, line 14, after "this" delete the remainder of the line in its entirety and insert
11 "Section."

12 AMENDMENT NO. 10

13 On page 4, at the end of line 15 insert "pursuant to this Section,"

14 AMENDMENT NO. 11

15 On page 4, delete lines 20 through 29 in their entirety, on page 5 delete lines 1 through 4 in
16 their entirety and insert the following:

17 "D. After complying with the provisions of Subsection C of this Section,
18 each fiscal year, the state treasurer shall disburse the avails of the tax levied pursuant
19 to Subsection A of this Section from sports wagering service providers or sports
20 wagering certificate holders as follows:

21 (1) One percent of avails of the tax levied in Subsection A of this Section, not
22 to exceed \$500,000 shall be credited to the Compulsive and Problem Gaming Fund
23 established by R.S. 28:842, and the remainder of the avails shall be credited to the
24 Louisiana Early Childhood Education Fund as established by R.S. 14:407.30.

25 (2) Ten percent of avails of the tax levied in Subsection A of this Section
26 shall be credited to the Louisiana Early Childhood Education Fund as established
27 by R.S. 17:407.30.

28 (3) Two percent of avails of the tax levied in Subsection A of this Section
29 shall be remitted, by proportionate distribution, to each parish governing authority
30 in which the taxable conduct occurred."
