 Provides relative to parole violations

Proposed law provides relative to the credit received for time served while on parole when parole is revoked and provides for the concurrent serving of the sentence imposed for the parole violation as well as any sentence imposed for a new offense.

EXPENDITURE EXPLANATION

Proposed law may result in a SGF expenditure savings for the Department of Public Safety and Corrections, Corrections Services (DOC) if a person is convicted in this state of a felony committed while on parole or is convicted under the laws of any other state or of the United States or any foreign government or country of an offense committed while on parole, and which if committed in this state would be a felony. Proposed law provides that the new sentence of imprisonment shall be served **concurrently with** the term of imprisonment for violation of parole, unless a **consecutive** term of imprisonment is directed by the court. Present law provides that new sentence of imprisonment shall be served **consecutively to** the term of imprisonment for violation of parole unless a **concurrent** term of imprisonment is directed by the court.

SGF expenditures will **decrease** by \$60.09 per offender per day if an offender is housed in a state facility or \$24.39 for a state offender housed in a local facility. Each year an offender is sentenced to the custody of the Department of Public Safety and Corrections - Correction Services creates an annual SGF expenditure obligation of \$21,992.03 (\$60.09 per day x 366 days) if housed in a state facility and \$8,926.74 (\$24.39 per day x 366 days) if housed in a local facility.

Currently, the cost for parole supervision is \$2.75 per day cost for parole supervision. The daily costs would be reduced accordingly.

Proposed law also makes a technical adjustment clarifying that when the parole of a parolee has been revoked by the committee for violation of the condition of parole, that he or she shall be returned to the physical custody of DOC and serve the remainder of the sentence as of the date of release on parole, with credit for any time served for good behavior while on parole. This technical adjustment produces no expenditure impact.

REVENUE EXPLANATION

There is no anticipated direct material effect on governmental revenues as a result of this measure.
