HOUSE FLOOR AMENDMENTS

2019 Regular Session

Amendments proposed by Representative Amedee to Reengrossed Senate Bill No. 169 by Senator Barrow

1 AMENDMENT NO. 1

2 On page 1, at the beginning of line 3, change "31.13(5) and (6), 31.14, and 31.16(A) and
3 (B)," to "31.13(1), (5), and (6), 31.14, 31.15, and 31.16(A) and (B), to enact R.S.
4 40:31.13(10),"

5 AMENDMENT NO. 2

6 On page 1, line 7, after "children;" and before "and to" insert "to provide protections for
7 persons who opt out of having information recorded in the registry;"

8 AMENDMENT NO. 3

9 On page 1, line 11, delete "31.13(5) and (6), 31.14," and insert in lieu thereof "31.13(1), (5),
10 and (6), 31.14, 31.15," and after "reenacted" and before "to read" insert "and R.S.
11 40:31.13(10) is hereby enacted"

12 AMENDMENT NO. 4

13 On page 1, at the beginning of line 14, insert "A."

14 AMENDMENT NO. 5

15 On page 2, between lines 7 and 8, insert the following:

16 **"B. The Louisiana Department of Health shall ensure that each**
17 **immunization registry established in accordance with this Part contains no**
18 **record whatsoever of any of the following persons:**

19 **(1) An adult who, in accordance with the procedure established by the**
20 **department in rule pursuant to R.S. 40:31.15, has opted out of having his**
21 **immunization information recorded in the registry.**

22 **(2) A child who has been opted out of having his immunization**
23 **information recorded in the registry by his custodial parent or legal guardian**
24 **in accordance with the procedure established by the department in rule**
25 **pursuant to R.S. 40:31.15.**

26 **(3) A person whose immunization record is to be purged from the**
27 **registry pursuant to a request made in accordance with R.S. 40:31.16(B).**

28 **C. No person who elects to opt out of having his immunization**
29 **information or that of his child recorded in the registry and no person who**
30 **requests that an immunization record be purged from the registry as authorized**
31 **by R.S. R.S. 40:31.16(B) shall be subject to any penalty for such election or**
32 **request.**

33 AMENDMENT NO. 6

34 On page 3, between lines 4 and 5, insert the following:

1 "(1) Immunization records of all clients born or living within the jurisdiction
2 of the agency that develops the register **except for persons who have been opted**
3 **out of inclusion in the registry and those clients whose immunization records**
4 **were purged from the registry pursuant to a request made in accordance with**
5 **R.S. 40:31.16(B).**"

6 AMENDMENT NO. 7

7 On page 3, between lines 14 and 15, insert the following:

8 **"(10) A feature which ensures that any record purged from the registry**
9 **pursuant to a request made in accordance with R.S. 40:31.16(B) is eliminated**
10 **completely from the registry's data system."**

11 AMENDMENT NO. 8

12 On page 4, delete line 11 in its entirety and insert in lieu thereof the following:

13 "§31.15. Rulemaking
14 A. The Louisiana Department of Health, office of public health, shall
15 promulgate rules and regulations pertaining to the development and implementation
16 of the immunization registries and their associated tracking and recall systems in
17 accordance with the Administrative Procedure Act. **These rules and regulations**
18 **shall provide, at minimum, for the functions, processes, and safeguards**
19 **specified in this Section.**
20 B. The rules shall include a process by which a custodial parent or guardian
21 can control the transfer of information from the immunization record or the
22 immunization tracking and recall record when such control is necessary to protect
23 the health or safety of the family.
24 C. **The rules shall provide for a process by which an adult may opt out**
25 **of having his immunization information recorded in the registry and a process**
26 **by which a child may be opted out of having his immunization information**
27 **recorded in the registry by his custodial parent or legal guardian."**
