Provides relative to autonomous commercial motor vehicles

Proposed law provides for definitions. Proposed law provides that autonomous commercial motor vehicles may operate in this state if in compliance with certain defined criteria, including: capable of operating in compliance with applicable federal law and traffic and motor vehicle laws of this state, properly registered and titled, certified in accordance with 49 CFR Part 567 as being in compliance with federal motor vehicle safety standards, capable of achieving a minimal risk condition if a failure occurs rendering the vehicle unable to perform dynamic driving tasks, and covered by motor vehicle liability coverage in an amount not less than \$2 million. Proposed law specifies that prior to commencing the operation of a commercial motor vehicle without a conventional driver present in the cab, a written statement shall be provided to the Department of Transportation and Development (DOTD) certifying that the vehicle meets the requirements contained in proposed law.

DOTD anticipates it will be able to absorb any potential additional workload using existing staff and resources.
