8 On page 2, line 13, after "minor" and before "seventeen" delete "sixteen or"

9 AMENDMENT NO. 4

10 On page 2, line 18, after "under" and before "may" delete "the age of sixteen" and insert
11 "seventeen years of age"

12 AMENDMENT NO. 5

13 On page 2, line 19, after "minor" and before "seventeen" delete "sixteen or"

14 AMENDMENT NO. 6

15 On page 2, line 20, after "without" and before "the" insert "judicial authorization and"

16 AMENDMENT NO. 7

17 On page 3, line 2, after "under" and before "shall" delete "the age of sixteen" and insert
18 "seventeen years of age"

19 AMENDMENT NO. 8

20 On page 3, line 3, after "issued." delete the remainder of the line and delete lines 4 and 5 in
21 their entirety and insert the following:

22 **"No marriage license for a minor seventeen years of age shall be issued**
23 **without the consent required by Children's Code Article 1545."**

24 AMENDMENT NO. 9

25 On page 3, at the beginning of line 10, delete "sixteen or older" and insert "seventeen years
26 of age"

1 AMENDMENT NO. 10

2 On page 3, line 10, after "minor has" and before "the written" insert "**received judicial**
3 **authorization as provided in Article 1547 and**"

4 AMENDMENT NO. 11

5 On page 3, delete line 11 in its entirety and insert "**one of the following:**"

6 AMENDMENT NO. 12

7 On page 3, delete line 15 in its entirety

8 AMENDMENT NO. 13

9 On page 3, at the end of line 19, delete "**the age of sixteen.**" and insert "**seventeen years of**
10 **age.**"

11 AMENDMENT NO. 14

12 On page 3, at the end of line 22, delete "**of the age of sixteen or seventeen,**"and insert
13 "**seventeen years of age,**"

14 AMENDMENT NO. 15

15 On page 3, at the end of line 25, delete "**the age of sixteen.**" and insert "**seventeen years of**
16 **age.**"
