Requires food service establishments serving imported crawfish or shrimp to inform patrons that the seafood is of foreign origin

Proposed law requires food service establishments serving imported crawfish or shrimp to inform patrons of the country of origin of that seafood and provides that failure to comply with the requirement is a violation of the state sanitary code.

**EXPENDITURE EXPLANATION**

There is no anticipated direct material effect on governmental expenditures as a result of this measure. The proposed legislation requires Louisiana Department of Health (LDH) to promulgate rules pursuant to the Administrative Procedure Act requiring food service establishments to inform patrons of the country of origin of certain seafood that it sells. Promulgating rules in accordance with the Administrative Procedure Act is a normal operating expense that is routinely included in the LDH annual budget and has no direct material effect on expenditures of the agency.

**REVENUE EXPLANATION**

There is no anticipated direct material effect on governmental revenues as a result of this measure. The bill provides that it is a violation of the Sanitary Code if a food service establishment does not inform patrons of the country of origin of certain seafood. However, the bill does not stipulate that LDH shall assess or collect a civil fine for the violation.
