4	WHEREAS, it is with great pride that the citizens of Louisiana and the House of
5	Representatives of the Legislature of Louisiana recognize Lena R. Torres for her many years
6	of public service and extraordinary accomplishments; and
7	WHEREAS, Lena Randazzo Torres is the daughter of the late Petrina Livaccari and
8	Sam Randazzo who were both descendants of Palermo, Italy; and
9	WHEREAS, she is a graduate of Maumus High School and a graduate of Soule'
10	Business College; and
11	WHEREAS, she was a loving and devoted wife to the love of her life, the late
12	Sidney D. Torres, is a committed mother and cherished grandmother, great-grandmother,
13	relative, and friend whose love of family and friends is of the utmost importance in her life;

15	WHEREAS, her long and illustrious career in public service has spanned over
16	seventy years, beginning and ending in the St. Bernard Clerk of Court's Office from 1940
17	to 1946, moving to the Louisiana County Agricultural Extension Division from 1946 to
18	1956, becoming Chief Deputy Clerk of Court from 1956 to 1988, and being appointed Clerk
19	of Court upon the death of her husband and Clerk of Court Sidney D. Torres Jr.; and
20	WHEREAS, she was elected Clerk of Court for St. Bernard Parish in 1988, was
21	reelected five times, and served until her retirement in 2012; and

1 WHEREAS, Lena is an exemplary and highly admired citizen of Louisiana who has 2 worked tirelessly on a multitude of business, civic, community, political, and religious 3 causes throughout her life; and 4 WHEREAS, she has been active and involved in numerous organizations: the 5 St. Bernard Society for Crippled Children, St. Bernard Business and Professional Women's 6 Club (Charter Member), St. Bernard Battered Women's Association, Louisiana Clerks of 7 Court Association, National Association of County Recorders, Election Officials and Clerks, 8 International Association of Clerks, Recorders, Elected Officials and Treasurers, Suburban 9 Woman's Club, Arabi Lions Women's Auxiliary, Chalmette Medical Center Auxiliary, Serra 10 Club of St. Bernard (Charter Member), American Association of Retired Persons, 11 Kiwanis Club, The Elenian Club, Canary Island Descendants Association, Los Islenos 12 Cultural & Heritage Society, and the St. Bernard Parish Retired Teachers Association; and 13 WHEREAS, her honors and awards are vast and include receiving the Alliance for 14 Good Government Past President's Award, Legislator of the Year in 1989, the Appreciation 15 Award from Chalmette Strutters in 1994, the Strength in Age Award from Louisiana State 16 University Medical Center in 1998, the Community Involvement Award for 1998-1999, 17 Chamber of Commerce C. "Bud" Colomb Award in 2001, Civic Recognition Award, St. 18 Bernard Business and Professional Women's Lifetime Achievement for Public Service to the 19 People of St. Bernard Parish in 2002, and received a certificate of Special Recognition for 20 fifty-two years of dedicated service from the Louisiana Center for Women and Government; 21 and 22 WHEREAS, she served on the Board of Directors at St. Bernard Bank & Trust from 23 1988 to 1997, as chairman of the St. Bernard Chapter March of Dimes in 1989, the Louisiana 24 Clerks of Court Association, Insurance Committee from 1994 to 1996, and 1999 to 2001, 25 the Louisiana Clerks of Court Association, board of directors from 1990 to 1992, and 26 1999 to 2001, Louisiana Clerks of Court Association, Court Appeal Liaison Committee from 27 1999 to 2001, as grand marshal at the Arabi School Mardi Gras Parade in 1994, as grand 28 marshal at San Pedro Pescador 50th Year Boat Blessing in 1997, as master of ceremonies 29 for the St. Bernard Catholic Church Caldo/Gumbo Festivadid in 1999, as hostess for 30 Cinemagic in 2000, St. Bernard Parish Choruses as honorary chairperson of Annual Sweet

1 Times in St. Bernard in 2001, Benefit Family Services of St. Bernard Children's Service 2 Fund, and as honorary hostess for Family Services of St. Bernard Children's Fund in 2001; 3 and 4 WHEREAS, Lena R. Torres was selected Woman of the Year by St. Bernard Business and Professional Women's Club for 1993-1994, Woman of Fashion, Men of 5 6 Fashion, Prix d'Elegance in 1993; and 7 WHEREAS, she was inducted into the Hall of Fame, Men of Fashion, Women of 8 Fashion, Prix d'Elegance in 2002, and into the Hall of Fame-Louisiana Center for Women 9 in Government and Business, Sports Hall of Fame, American Italian Society in 2002; and 10 WHEREAS, Lena R. Torres was recognized in 2009 by the Louisiana State Senate 11 and House of Representatives in Senate Concurrent Resolution No. 153 and House 12 Resolution No. 135 for her many years of invaluable public service to the citizens of 13 St. Bernard Parish; and 14 WHEREAS, she is a staple and St. Bernard Parish fixture who deserves to be 15 honored and respected for her commitment to public service, community involvement, and 16 the positive impact she has bestowed on her community, parish, and the state of Louisiana; 17 and 18 WHEREAS, not only is Lena R.
