ASSESSORS. Provides relative to the authority of the Insurance Committee of the Assessors' Insurance Fund to contract for group insurance. (8/1/20)

2 To amend and reenact R.S. 47:1922(A)(1), relative to the Insurance Committee of the
3 Assessors' Insurance Fund; to provide relative to the authority of the Insurance
4 Committee of the Assessors' Insurance Fund to contract for group insurance; to
5 remove provision requiring final approval by the Louisiana Assessors' Association
6 membership; and to provide for related matters.
7 Be it enacted by the Legislature of Louisiana:
8 Section 1. R.S. 47:1922(A)(1) is hereby amended and reenacted to read as follows:
9 §1922. Creation of assessors' insurance fund and committee with authority to
10 contract for group insurance; payment of premiums
11 A.(1) There is hereby created an Assessors' Insurance Fund for the assessors
12 and assessors' employees throughout the state and a public corporation to be known
13 as the "Insurance Committee of the Assessors' Insurance Fund", ~~which~~. **This**
14 committee shall be vested with the power to administer the ~~fund herewith provided~~
15 **for Assessors' Insurance Fund**, to sue and be sued, to bid for, then contract for and
16 pay premiums for group life and accidental death and dismemberment insurance and
17 group health, accident, dental, hospital, surgical, and other medical expense

1 insurance for the assessors, assessors' employees, and dependents of the assessors

SB 414 Original 2020 Regular Session Foil

Present law (R.S. 47:1922) creates an Assessors' Insurance Fund for the assessors and assessors' employees throughout the state and a public corporation known as the Insurance Committee of the Assessors' Insurance Fund.

Proposed law retains present law.

Present law authorizes the Insurance Committee of the Assessors' Insurance Fund to administer the fund, to sue and be sued, to bid for, then contract for and pay premiums for group life and accidental death and dismemberment insurance and group health, accident, dental, hospital, surgical, and other medical expense insurance for the assessors, assessors' employees, and dependents of the assessors and assessors' employees with any insurance company legally authorized to do business in this state after final approval by a majority vote of the La. Assessors' Association membership.

Proposed law removes the provision requiring final approval by a majority vote of the La. Assessors' Association membership and otherwise retains present law.

Effective August 1, 2020.
