Requires certain public trusts to obtain approval of a parish or municipal governing authority under certain circumstances prior to undertaking an authorized public function or purpose

Purpose of the Bill: This bill adds a requirement that a public trust which has a Parish, Municipality, or other Political or Governmental Subdivision as its beneficiary, must obtain approval through resolution, from this Parish or Municipal governing authority, prior to carrying out any public function or purpose outside of the geographic boundaries of this beneficiary.
