Subject: Identification Cards w/Real ID for Persons Age 60+ years	

FEES/LICENSES/PERMITS OR NO IMPACT See Note Page 1 of 1
Provides for a special identification card for persons over the age of 60. (8/1/20)

Present law provides that persons age 60 years or older may obtain an identification card without charge; and these identification cards shall not expire. Proposed law provides that persons age 60 years or older may obtain an identification card that complies with the standards of Real ID without charge. Proposed law provides that Real ID cards expire every 6 years. Proposed law provides that the Department of Public Safety and Correction, Public Safety Services, Office of Motor Vehicles can issue a Real ID card to person age 60 years or older with an expiration of less than 6 years under legal presence circumstances or other special restrictions. Proposed law effective August 1, 2020.
