23 A. In the event of the legalization of sports wagering in any parish 24 as a result of the proposition election held on November 3, 2020, the 25 Louisiana Gaming Control Board shall have all regulatory authority, control, and jurisdiction, including investigation, licensing, and 26 27 enforcement, and all power incidental or necessary to such regulatory 28 authority, control, and jurisdiction over all aspects of sports wagering 29 activities and operations, except as otherwise specified in this Title. B. For purposes of this Section, "sports wagering" shall be 30 31 defined as the business of accepting wagers on any sports event or sports 32 contest by any system or method of wagering."

- 33 <u>AMENDMENT NO. 8</u>
- 34 On page 12, line 3, change "Section 6." to "Section 3."
- 35 AMENDMENT NO. 9
- 36 On page 12, delete lines 5 through 14 and insert the following:

"Section 4. Section 2 of this Act shall become effective January 1,
2021, if in the statewide election to be held on November 3, 2020, a majority
of the qualified electors in at least one parish in the state vote to approve the
proposition to permit sports wagering in such parish. However, sports
wagering shall not be authorized by the Louisiana Gaming Control Board in
such parish until state laws providing for the licensing, regulation, and
taxation of sports wagering activities and operations are enacted and become
effective.

 Section 5. Sections 1, 3, 4 and this Section shall become effective June 10, 2020."
