1 AMENDMENT NO. 1

2 On page 1, line 2, after "To" and before "relative to" delete "enact R.S. 40:964(Schedule
3 I)(D)(6) and (7) and (Schedule IV)(D)(14)," and insert "amend and reenact R.S.
4 40:964(Schedule II)(A)(1)(introductory paragraph) and (E)(3) and to enact R.S.
5 40:964(Schedule I)(A)(68) through (71), (D)(6) and (7), (Schedule IV)(B)(2.1) and (25.1)
6 and (D)(14), and (Schedule V)(D)(5) and (6),"

7 AMENDMENT NO. 2

8 On page 1, delete line 4 in its entirety and insert "Schedules I, II, IV, and V; to provide
9 relative to substances of vegetable origin or chemical synthesis in Schedule II; and to
10 provide for related matters."

11 AMENDMENT NO. 3

12 On page 1, delete lines 6 and 7 in their entirety and insert "Section 1. R.S. 40:964(Schedule
13 II)(A)(1)(introductory paragraph) and (E)(3) are hereby amended and reenacted and R.S.
14 40:964(Schedule I)(A)(68) through (71), (D)(6) and (7), (Schedule IV)(B)(2.1) and (25.1)
15 and (D)(14), and (Schedule V)(D)(5) and (6) are hereby enacted to read as follows:"

16 AMENDMENT NO. 4

17 On page 1, between lines 12 and 13, insert the following:

18 "A. Opiates. Unless specifically excepted or unless listed in another
19 schedule, any of the following opiates, including their isomers, esters, ethers, salts,
20 or salts of isomers, esters, and ethers, whenever the existence of such isomers, esters,
21 ethers, or salts is possible within the specific chemical designation:

30 On page 2, between lines 3 and 4, insert the following:

32 A. Substances of vegetable origin or chemical synthesis. Unless specifically
33 excepted or unless listed in another schedule, any of the following substances
34 whether produced directly or indirectly by extraction from substances of vegetable
35 origin, or independently by means of chemical synthesis, or by a combination of
36 extraction and chemical synthesis:

37 (1) Opium and opiate, and any salt, compound, ~~isomer~~, derivative, or
38 preparation of opium or opiate, excluding apomorphine, thebaine-derived
39 butorphanol, dextrorphan, nalbuphine, naldemedine, nalmefene, naloxegol,
40 naloxone, 6β-naltrexol, and naltrexone, and their respective salts, but including the

11 On page 2, between lines 4 and 5, insert the following:

14 schedule, any material, compound, mixture, or preparation containing any quantity
15 of the following substances, including its salts, isomers, and salts of isomers,
16 whenever the existence of such salts, isomers, and salts of isomers is possible within
17 the specific chemical designation:

35 AMENDMENT NO. 8

36 On page 2, line 15, after "R.S. 40:964(Schedule I)(D)" and before "to ensure" insert a
37 comma "," followed by "(Schedule IV)(B), and (Schedule V)(D)"
