ATTORNEYS. Requests the Louisiana Supreme Court and the Louisiana State Bar Association to implement a lawyer advertisement review recognition program.

A CONCURRENT RESOLUTION

2	To urge and request the Louisiana Supreme Court and the Louisiana State Bar Association
3	to implement a lawyer advertisement review recognition program.
4	WHEREAS, Article V, Section 5(B) of the Constitution of Louisiana provides that
5	the Louisiana Supreme Court has exclusive original jurisdiction of disciplinary proceedings
6	against a member of the bar; and
7	WHEREAS, the Louisiana Supreme Court has adopted the Louisiana Rules of
8	Professional Conduct, and the Louisiana State Bar Association created the Handbook on
9	Lawyer Advertising and Solicitation, which contains standards and guidance regarding
10	attorney advertising; and
11	WHEREAS, the Louisiana State Bar Association has been tasked by the Louisiana
12	Supreme Court with providing a review process for lawyer advertising and solicitation
13	compliance; and
14	WHEREAS, challenges to the constitutionality of Rules of Professional Conduct
15	regulating attorney advertising were filed in federal district court, and ultimately resulted in
16	the federal Fifth Circuit Court of Appeals decision in Public Citizen, Inc. v. Louisiana
17	Attorney Disciplinary Board, 632 F. 3d 212 (2011); and
18	WHEREAS, in the Public Citizen case, the Court struck down certain state rule

1	requirements as infringing upon First Amendment protections regarding commercial speech,
2	but upheld other rule requirements as the legitimate exercise by the state of its substantial
3	interests in protecting the public from unethical and false, deceptive, and misleading lawyer
4	advertising, and also in preserving the ethical integrity of the legal profession; and
5	WHEREAS, in the Public Citizens case, the Court reaffirmed that commercial free
6	speech in the form of attorney advertising is not absolute, but instead merits a limited
7	measure of protection subject to differing levels; and
8	WHEREAS, in the Public Citizens case, the Court reaffirmed that the state does have
9	substantial interests in regulating attorney advertising to prevent unlawful activity and the
10	deception and confusion of consumers, including claims and depictions of scenes and
11	pictures in attorney advertising inherently likely to deceive the public; and
12	WHEREAS, in the Public Citizens case, the Court pointed out that the United States
13	Supreme Court has recognized the government's substantial interests in "ensuring the
14	accuracy of commercial information in the marketplace" and "maintaining standard of
15	ethical conduct in the licensed professions", and has further recognized that a state's interest
16	in regulating attorneys is especially great since lawyers are essential to the primary
17	governmental function of administering justice, and have historically been "officers of the
18	courts"; and
19	WHEREAS, in light of these substantial interests, the Louisiana Supreme Court and
20	the Louisiana State Bar Association should undertake the task of creating a lawyer
21	advertisement review recognition program to identify all advertisements which have been
22	reviewed by the Louisiana State Bar Association for compliance with the Louisiana Rules
23	of Professional Conduct, and should further implement such a public database of the review
24	recognition program.
25	THEREFORE, BE IT RESOLVED that the Legislature of Louisiana does hereby
26	urge and request the Louisiana Supreme Court and the Louisiana State Bar Association to
27	implement a lawyer advertisement review recognition program.
28	BE IT FURTHER RESOLVED that on or before December 1, 2020, the Louisiana
29	Supreme Court and the Louisiana State Bar Association shall submit to the Senate

the David R. Poynter Legislative Research Library a report addressing the actions it has taken or plans to take towards implementing a lawyer advertisement review recognition program.
