<u>Proposed law</u> amends and reenacts specific parts of the law pertaining to photo identification for people released from incarceration to now include a list of all licensing and certification programs completed while incarcerated.

EXPENDITURE EXPLANATION

<u>Proposed law</u> will result in an increase in SGF expenditures to the Department of Public Safety and Corrections - Corrections Services (DPSC - CS) to implement. DPSC - CS currently provides offenders with an official Office of Motor Vehicle (OMV) state ID upon release. The official OMV state ID cannot be altered; therefore, if this legislation passes, DPSC - CS will provide a secondary form of "non official" ID. The secondary form of ID would cost around \$5 per person.

There are approximately 16,000 people released each year. It would cost the state an additional \$80,000 per year to provide a secondary form of ID with the information required in the <u>proposed law</u>. DPSC - CS currently issues a certificate of completed courses in the release packet.

REVENUE EXPLANATION

There is no anticipated direct material effect on governmental revenues as a result of this measure.
